BARANGAY ORDINANCE NO. 02 SERIES OF 2026

AN ORDINANCE IMPLEMENTING BARANGAY ROAD CLEARING OPERATIONS IN BARANGAY ZAPOTE I AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, the Sangguniang Barangay of Zapote 1, is mandated to ensure the maintenance of peace, order, safety, and convenience of its residents;

WHEREAS, road obstructions such as illegally parked vehicles, illegal structures, construction materials, vendor stalls, and other impediments cause traffic congestion and pose danger to pedestrians and motorists;

WHEREAS, under the Local Government Code of 1991 (RA 7160), the Barangay has the authority to regulate the use of barangay roads and ensure that public roads remain free from obstruction;

NOW THEREFORE, upon motion of Hon. Medel D. Fabian, duly seconded by Hon. Edwin B. Capayas, be it **ORDAINED** by the Sangguniang Barangay of Barangay Zapote I, Bacoor City, that:

SECTION 1. TITLE

This Ordinance shall be known as the **"Barangay Zapote I Road Clearing Ordinance of 2026."**

SECTION 2. COVERAGE

This Ordinance shall apply to all barangay roads, alleys, sidewalks, and public pathways within the territorial jurisdiction of Barangay Zapote I.

SECTION 3. PROHIBITED ACTS

The following acts are strictly prohibited:

1. Obstructing barangay roads, sidewalks, and public pathways.
2. Illegal parking that blocks traffic flow or pedestrian access.
3. Placing construction materials, debris, or other objects on public roads without permit.
4. Installation of illegal structures, extensions, or encroachments on public roads and sidewalks.
5. Operating vending stalls or businesses occupying public roads without authorization.

SECTION 4. ROAD CLEARING OPERATIONS

The Barangay Officials, Barangay Tanods, and authorized personnel are hereby empowered to:

1. Conduct regular road clearing operations;
2. Issue notices of violation;
3. Remove illegal obstructions;
4. Coordinate with city authorities when necessary.

SECTION 5. PENALTIES

Any person found violating this Ordinance shall be penalized as follows:

- **First Offense** – Warning and removal of obstruction
- **Second Offense** – Fine of ₱1,000.00
- **Third Offense** – Fine of ₱1,500.00 and confiscation of materials/structures

Failure to comply may result in further legal action in accordance with existing laws and ordinances.

SECTION 6. SEPARABILITY CLAUSE

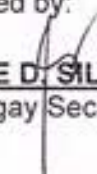
If any provision of this Ordinance is declared invalid, the remaining provisions shall remain in full force and effect.

SECTION 7. EFFECTIVITY

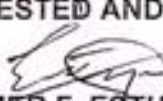
This Ordinance shall take effect upon approval and posting in at least three (3) conspicuous places within Barangay Zapote I.
