BARANGAY ORDINANCE NO. 3 SERIES OF 2026

AN ORDINANCE PROHIBITING DRINKING OF ALCOHOLIC BEVERAGES IN PUBLIC AND ANY ACTS CAUSING PUBLIC DISTURBANCE WITHIN THE JURISDICTION OF BARANGAY ZAPOTE 1, CITY OF BACOR, CAVITE

WHEREAS, it is the duty of the Barangay to maintain peace, order, and safety within its territorial jurisdiction;

WHEREAS, there have been increasing incidents of public disturbance caused by intoxicated individuals in public places;

WHEREAS, there is a need to protect residents, especially minors, senior citizens, and the general public from nuisance and disorder;

NOW THEREFORE, be it ordained by the Sangguniang Barangay of Barangay Zapote 1, that:

SECTION 1. TITLE This ordinance shall be known as the "Anti-Public Drinking and Public Disturbance Ordinance of Barangay Zapote 1."

SECTION 2. DEFINITION OF TERMS

- a. Public Place – streets, sidewalks, alleys, parks, playgrounds, basketball courts, waiting sheds, and other areas accessible to the public.
- b. Public Drinking – consumption of alcoholic beverages in public places.
- c. Public Disturbance – acts such as shouting, loud music, fighting, harassment, or any behavior that disrupts peace and order.

SECTION 3. PROHIBITED ACTS It shall be unlawful for any person to:

- 1. Drink alcoholic beverages in any public place;
- 2. Cause public disturbance while under the influence of alcohol;
- 3. Display drunken behavior that threatens public safety.

SECTION 4. PENALTIES Any person found violating this ordinance shall be penalized as follows:

- 1st Offense: ₱ 300.00 (three hundred pesos only) or community service
- 2nd Offense: ₱ 500.00 (five hundred pesos only) fine or 16 hours community service
- 3rd Offense: ₱ 1,000.00 (one thousand pesos only) fine and/or referral to proper authorities

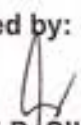
SECTION 5. IMPLEMENTING AUTHORITY This ordinance shall be enforced by the Barangay Officials, Barangay Tanod, and other authorized personnel.

SECTION 6. SEPARABILITY CLAUSE If any provision of this ordinance is declared invalid, other provisions shall remain in full force and effect.

SECTION 7. EFFECTIVITY This ordinance shall take effect immediately upon approval and proper posting in conspicuous places within the Barangay.

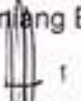
