A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE PROVINCIAL GOVERNMENT OF CAVITE REGARDING THE GRANT OF FINANCIAL ASSISTANCE AMOUNTING TO TWO MILLION PESOS (PHP2,000,000.00) TO THE CITY GOVERNMENT.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, on 16 July 2026, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Honorable Strike B. Revilla, to sign a Memorandum of Agreement (MOA) with the Provincial Government of Cavite (PGC) represented By Hon. Francisco Gabriel D. Remulla on behalf of the City Government of Bacoar.

WHEREAS, the City Government of Bacoar has tourism-related programs, projects and activities which include, among others, the celebration of the 14th Bacoar Cityhood Anniversary, the 3rd Barangay Merging Anniversary and the City's 355th Founding Anniversary (Bakood Festival 2026).

WHEREAS, the City Government of Bacoar is in need of funds for the implementation of the aforementioned activities;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement"), is made and entered into this ____ day of _____, 2026 (the "Effective Date") in _____, Province of Cavite, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a political subdivision of the Republic of the Philippines, with official address at the Provincial Capitol Compound, Trece Martines City, Province of Cavite, represented herein by its Governor, **FRANCISCO GABRIEL D. REMULLA**, duly authorized for the purpose, hereinafter referred to as the "**FIRST PARTY**"

and

The **CITY GOVERNMENT OF BACOR**, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with its principal office address at Bacoar Government Center, Bacoar Boulevard, Barangay Bayanan, City of Bacoar, Province of Cavite, represented herein by its City Mayor, **STRIKE B. REVILLA**, duly authorized for the purpose, hereinafter referred to as the "**SECOND PARTY**"

The term "**PARTY**" shall mean the **FIRST PARTY** or the **SECOND PARTY**, if applicable, while the term "**PARTIES**" shall mean the **FIRST PARTY** and the **SECOND PARTY**, collectively.

WITNESSETH:

WHEREAS, Republic Act (R.A) No. 7160, otherwise known as the "Local Government Code of 1991," specifically provides that the local government units (LGUs) shall endeavor to be self-reliant and continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, LGUs shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities essential to the promotion of the general welfare;

WHEREAS, these powers of the LGUs include the implementation of priority programs and projects for the provision of the basic services and facilities as embodied under the Local Government Code of 1991, including, among others, the promotion of tourism, preservation of cultural heritage, and related socio-economic initiatives designed to foster local talents and advance community development;

WHEREAS, the **SECOND PARTY** is in need of funds for the implementation of its priority programs and projects pertaining to tourism-related events of the City

of Bacoor, such as the 14th Cityhood Anniversary, the 3rd Barangay Merging Anniversary, and the 355th Founding Anniversary of Bacoor;

WHEREAS, the **FIRST PARTY** may extend financial assistance to its component cities in aid of the implementation of basic services and facilities;

WHEREAS, the **SECOND PARTY** possesses the administrative and technical capability to fully implement the aforesaid programs in close coordination with the **FIRST PARTY**;

WHEREAS, the Sangguniang Panlalawigan of Cavite passed Resolution No. _____, Series of 2026, authorizing the Governor, **HON. FRANCISCO GABRIEL D. REMULLA**, to enter into Memoranda of Agreement with the LGUs in the Province of Cavite for the grant of financial assistance to said LGUs;

WHEREAS, the Sangguniang Panlungsod of Bacoor, Cavite, passed City Resolution No. _____, Series 2026, authorizing the City Mayor, **HON. STRIKE B. REVILLA**, to enter into a Memorandum of Agreement with the Provincial Government of Cavite for the grant of financial assistance to the City of Bacoor and for compliance with the fund requirements;

NOW, THEREFORE, for and in consideration of the foregoing premises and the terms and conditions hereinafter enumerated, the **PARTIES** to this Agreement hereby agree as follows:

1. The **PARTIES** shall take the necessary actions to cooperate with each other and to perform their respective duties and responsibilities in order to achieve the objectives of this Agreement;
2. The **FIRST PARTY** shall grant financial assistance to the **SECOND PARTY** to support the latter in the delivery of basic services and in the implementation of its priority programs, projects, and activities;
3. The **SECOND PARTY** shall promptly submit the approved project expenditures or the estimated expenses, clearly indicating the project objectives and expected outputs, for approval by the **FIRST PARTY**;
4. The **SECOND PARTY** shall exclusively utilize the funds for the implementation of its priority programs, projects, and activities, in accordance with existing government budgeting, procurement, accounting, and auditing rules and regulations;
5. The **SECOND PARTY** shall keep track of, and prepare an accounting of, all disbursements of the financial assistance granted by the **FIRST PARTY** for the **SECOND PARTY**'s priority programs, projects, and activities;
6. Within fifteen (15) days after the fund utilization, the **SECOND PARTY** shall submit to the **FIRST PARTY** a written summary and accomplishment report of the implemented activities, together with a liquidation report. Said submission shall include certified true copies of supporting documents for the implementation of the priority programs and projects, as well as such other information reasonably necessary for the purpose and as may be required by the **FIRST PARTY**;

7. The **SECOND PARTY** shall refund or return any unexpended or unutilized balance of funds to the Provincial Treasurer's Office;
8. The **FIRST PARTY** shall not authorize the subsequent release of funds to the **SECOND PARTY** if there remain unliquidated balances;
9. All payments and releases by the **SECOND PARTY** under the priority programs and projects funded by the **FIRST PARTY** shall be made in accordance with existing government accounting and auditing rules and regulations; and
10. Both **PARTIES** agrees to establish mechanisms for monitoring and evaluating the effectiveness of the funded programs, projects, and activities.
