AN ORDINANCE PROHIBITING THE USE OF OPEN MUFFLERS, MODIFIED MUFFLERS, AND OTHER NOISY EXHAUST SYSTEMS WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY SALINAS 2, PROVIDING PENALTIES THEREFOR, AND FOR OTHER PURPOSES WHEREAS,

WHEREAS, Section 16 of the Local Government Code of 1991 empowers local government units to promote the general welfare, peace, and order of their constituents;

WHEREAS, excessive noise caused by open or modified mufflers disturbs residents, affects public health, and disrupts the peace and tranquility of the community;

WHEREAS, complaints have been received from residents regarding motorcycles and other motor vehicles using open mufflers, especially during nighttime; and

WHEREAS, the Barangay Council deems it necessary to regulate and prohibit the use of open mufflers to protect the welfare of the residents. Similar anti-noise and anti-modified muffler measures have been adopted by several local governments in the Philippines.

NOW, THEREFORE, be it ordained by the Sangguniang Barangay in session assembled:

SECTION 1. TITLE. This Ordinance shall be known as the "Anti-Open Muffler Ordinance of Barangay Salinas 2."

SECTION 2. DEFINITION OF TERMS. Open Muffler – an exhaust system without a functional silencer or baffle, producing excessive noise. Modified Muffler-any muffler altered from its original manufacturer specifications in a manner that significantly increases noise emissions.

SECTION 3. PROHIBITED ACTS. It shall be unlawful for any person to: Operate a motorcycle or motor vehicle equipped with an open muffler; Use a modified muffler that produces excessive or disturbing noise; Rev, race, or deliberately create loud exhaust noise within the barangay.

SECTION 4. AREAS OF STRICT ENFORCEMENT shall be observed near: Schools Churches and places of worship Hospitals and Health centers Residential areas Government offices

SECTION 5. PENALTIES Any person found violating this Ordinance shall be subject to:

- First Offense: Warning and community service of 2 hours
- Second Offense: Fine of P500.00
- Third Offense: Fine of P1,000.00 and endorsement to the City Traffic Office or PNP for appropriate action.

SECTION 6. ENFORCEMENT. The Barangay Peacekeeping Action Team (BPAT), Barangay officials, and other authorized law enforcement agencies shall assist in the implementation of this Ordinance.

SECTION 7. Information Campaign the Barangay shall conduct an information campaign regarding the harmful effects of noise pollution and the provision and the provisions of this ordinance.

SECTION 8. Separability Clause if any provision of this ordinance is declared invalid, the remaining provisions shall continue to be in full force and effect.

SECTION 9. Effectivity This Ordinance shall take effect immediately upon approval and posting in conspicuous places within the Barangay.
