A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION BETWEEN THE CITY GOVERNMENT OF BACOOR AND THE OFFICE OF THE PRESIDENT REGARDING THE TWO MILLION PESOS (Php2,000,000.00) CASH ASSISTANCE TO SUPPORT THE PARTICIPATION OF THE EL GOBERNADOR BAND AND UNITED MUSICIANS OF THE CITY OF BACOOR IN THE 29TH LES BANDAFOLIE FESTIVAL IN BESSINES-SUR-GARTEMPE, FRANCE.

WHEREAS, Article XIV, Section 14 of the 1987 Philippine Constitution mandates that the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino nation culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, on 30 July 2026, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign a Deed of Donation between the City government of Bacoor and the Office of the president regarding the two million pesos (Php 2,000,000.00) cash assistance to support the participation of the El Gobernador and united Musicians of the City of Bacoor in the Les Bandafolie festival in Business-Sur-Gartempe, France.

WHEREAS, the City government of Bacoor is in need of funds for the implementation of the aforementioned activities;

WHEREAS, a draft Deed of Donation and (DOD) was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

DEED OF DONATION

KNOW ALL MEN BY THESE PRESENTS:

This Deed of Donation made and entered into by and between:

The **OFFICE OF THE PRESIDENT (OP)**, represented by **SENIOR DEPUTY EXECUTIVE SECRETARY MARIA LUWALHATI C. DOROTAN TIUSECO**, with office address at Bonifacio Hall, Malacañang Compound, J.P. Laurel St., San Miguel, Manila and hereinafter referred to as the **DONOR**;

- and -

The **CITY OF BACOR, CAVITE**, a local government unit of the Republic of the Philippines, with principal address at Bacor Government Center, Bacor Boulevard, Barangay Bayanan, Bacor City, Cavite, represented by **MAYOR STRIKE B. REVILLA**, hereinafter referred to as the **DONEE**;

WITNESSETH:

WHEREAS, Article XIV, Section 14 of the 1987 Philippine Constitution mandates that the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, the State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations;

WHEREAS, Article XIV, Section 17 of the 1987 Philippine Constitution provides that the State shall recognize, respect, and protect the rights of indigenous cultural communities to preserve and develop their cultures, traditions, and institutions;

WHEREAS, the Philippine Development Plan acknowledges the collaboration among the government, private sector, academe, civil society, and representatives from marginal sectors, such as the indigenous peoples, to bolster and to secure sustainable production, accelerate rehabilitation and conservation efforts, and strengthen enforcement of environmental rules and regulations, and optimize their economic potential;

WHEREAS, Mayor Revilla requested financial assistance to support the participation of the El Gobernador Band (EGB) and the United Musicians of City of Bacor (UMCB) in the 29th Les Bandafolie Festival in Bessines-sur-Gartempe, France;

WHEREAS, Section 2.8 of Office Order No. 20, s. 2026 "Revised General Guidelines on the Management and Administration of the Socio-Civic Projects Fund (SCPF)" provides that other forms of special assistance, financial or otherwise, may be granted to target individuals, community, institution, or group beneficiaries for other socio-civic purposes;

NOW, THEREFORE, for and in consideration of the foregoing premises and of the terms, conditions, and covenants hereinafter set forth, the Parties agree to the following:

1. The **DONOR** hereby donates to the **DONEE** the total amount of **Two Million Pesos (P2,000,000.00)**, from the **SCPF**, by virtue of **OP Office Order No. 20 s. of 2026**, and approved Memorandum by the Office of the Executive Secretary dated **09 July 2026**.
2. The **DONOR** shall release the total amount of **P2,000,000.00** as **SCPF** assistance to support the participation of the **El Gobernador Band** and the **United Musicians of City of Bacoor** in the Festival.
3. The **DONEE** accepts the donation with gratitude and agrees to use the said amount for the purpose stated in the preceding paragraph.
4. The **DONEE** hereby states, for the purpose of giving full force, effect, and validity to this donation, the following:
 - a. The donation shall be used solely for the aforementioned purpose;
 - b. No realignment shall be made without the prior written approval of the **DONOR**, and any modification or amendment to the terms and conditions of this Deed shall likewise be subject to the prior written approval of the **DONOR**;
 - c. The **DONEE** shall submit to the **DONOR** a Fund Utilization Report within sixty (60) days from the culmination of the Festival, supported with official receipts from the actual expenses incurred for the fund given. Any unutilized amount after completion of the festival shall be returned to the **DONOR**; and
 - d. In case of violation of the preceding provisions, the **DONOR** shall have the right to revoke the donation, without prejudice to the filing of the appropriate criminal, civil, or administrative actions against the **DONEE**.
