A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN ALL BARANGAYS OF THE CITY OF BACOR, CAVITE DUE TO MASSIVE FLOODING CAUSED BY THE ENHANCED EFFECTS OF THE SOUTHWEST MONSOON EXACERBATED BY TYPHOON DOLPHIN AND AUTHORIZING THE RELEASE OF EIGHT MILLION PESOS (PHP 8,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR FINANCIAL ASSISTANCE, RELIEF GOODS PROCUREMENT, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.
