CITY RESOLUTION NO. 2026-1086

Series of 2026

A RESOLUTION AUTHORIZING THE CITY MAYOR TO CAUSE THE FILING OF THE APPROPRIATE PETITION BEFORE THE COMMISSION ON ELECTIONS FOR THE ISSUANCE OF A CERTIFICATE OF EXEMPTION AND AUTHORITY IN FAVOR OF THE CITY GOVERNMENT OF BACOR, CAVITE TO: (1) RELEASE, DISBURSE, AND EXPEND PUBLIC FUNDS, (2) CONSTRUCT PUBLIC WORKS, DURING THE ELECTION BAN TO BE IMPLEMENTED IN RELATION TO THE 2026 BARANGAY AND SANGGUNANG KABATAAN ELECTIONS.

WHEREAS, the Commission on Elections (Comelec) promulgated Resolution No. 11191 on 28 January 2026 pertaining to the calendar of activities and periods of certain prohibited acts in connection with the 2 November 2026 Barangay and Sangguniang Kabataan Elections (BKSE).

WHEREAS, Comelec Resolution No. 11191 provides that, beginning on 18 September 2026 until 1 November 2026, all public officials may no longer release, disburse, or spend public funds pursuant to Section 261 (n) of the Omnibus Election Code.

WHEREAS, the same Comelec resolution also prohibits the construction of public works, the delivery of materials for public works and the issuance of treasury warrants and other similar devices in accordance with Section 261 (w) of the Omnibus Election Code.

WHEREAS, on 4 August 2026, the Sangguniang Panlungsod Secretariat received a letter signed by Mayor Strike B. Revilla formally requesting the City Council to "perform the appropriate actions that will grant (him) the authority necessary to represent the City Government of Bacoor and sign the petition for the issuance of a Certificate of Exemption and authorization to release, disburse, and expend public funds".

WHEREAS, considering that the said request was certified as urgent by the City Mayor, the Sangguniang Panlungsod immediately upon the said request and called for a hearing for the said purpose. During the said hearing,

attended by the heads of the various departments and units under the Office of the City Mayor as well as representatives of the Office of the Vice Mayor, it was learned that the aforementioned request seeks to obtain a Certificate of Exemption from the Comelec in favor of the City Government from complying with the ban on the performance of some of the various officials acts mentioned above so as not to hamper the delivery of vital public services within the City of Bacoor.

WHEREAS, in view of the foregoing, the members of the Sangguniang Panlungsod unanimously decided to empower the City Mayor – or his duly authorized representative – to cause the filing of a petition with the Comelec for the issuance of a Certificate of Exemption in favor of the City Government and authorize the performance of various official acts that will not in any way affect or influence the outcome of the BKSE in the City of Bacoor, Cavite particularly the:

(1) release, disbursement, and expenditure of public funds by the Office of the City Mayor as well as by the Office of the Vice Mayor and other departments and units under the said offices, (2) the construction of various public works by contractors with existing projects with the City Government or with the National Government within the City of Bacoor, and from 18 September 2026 until 1 November 2026.

NOW THEREFORE, upon motion of Honorable Reynaldo D. Palabrica, duly seconded by the rest of the City Council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite to empower the City Mayor, Honorable Strike B. Revilla, – or his duly authorized representative – to cause the filing of a petition with the Commission on Elections for the issuance of a Certificate of Exemption in favor of the City Government and authorize the performance of various official acts that will not in any way affect or influence the outcome of the BKSE in the City of Bacoor, Cavite.

RESOLVED LASTLY, to furnish the Commission on Elections, the Office of the City Mayor, and other government offices/agencies concerned with certified true copies of this Resolution.
