**CITY RESOLUTION NO. 2026-1100**

**Series of 2026**

**A RESOLUTION DISALLOWING FUTURE PURCHASES OF ALL-TERRAIN VEHICLES (ATV) BY THE VARIOUS BARANGAYS OF THE CITY OF BACOR, CAVITE DUE TO PUBLIC SAFETY CONCERNS.**

**WHEREAS**, Section 11 (1) (i) of Republic Act No. 10160 (the "Charter of the City of Bacoor") gave the Sangguniang Panlungsod the power to review all ordinances approved by sangguniang barangays and executive orders issued by all punong barangay in the City of Bacoor to determine whether these are within the scope of the prescribed powers of the said sangguniang barangays and of the punong barangay.

**WHEREAS**, Section 11 (5) (viii) of RA 10160 likewise empowered the Sangguniang Panlungsod to adopt measures to ensure public safety against open canals, manholes, live wires and other similar hazards to life and property.

**WHEREAS**, Section 333 of Republic Act No. 7160 (the "Local Government Code of 1991") gave the Sangguniang Panlungsod the power to review appropriation ordinances passed by the sangguniang barangay.

**WHEREAS**, various memoranda issued by the Land Transportation Office (LTO) banned the use of all-terrain vehicles (ATVs) from public roads because: (1) they lack essential safety equipment such as signal lights and safety mirrors as well as structural protection for high-speed travel on paved roads, and because (2) there are no existing motor vehicle registration guidelines for ATVs.

**WHEREAS**, because of the aforecited reasons, ATVs that are used on public roads pose a serious risk to public safety and may result in the confiscation of the license plate and the impoundment of the said vehicles by the LTO.

**NOW THEREFORE**, upon the unanimous motion of all city councilors present, and considering the reasons aforecited, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6<sup>th</sup> Sangguniang Panlungsod in regular session duly assembled to **disallow** future purchases of All-Terrain Vehicles (ATVs) by the various barangays in the City of Bacoor due to the above-mentioned public safety concerns and in recognition of relevant LTO guidelines.

**RESOLVED LASTLY** to direct the Sangguniang Panlungsod Secretariat to furnish copies of this Resolution via electronic mail to all barangays in the City of Bacoor and through personal service to the City Accountant, the City Planning Development and Coordinator, the City Budget Officer, and the Office of the City Mayor.
