A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY PUNONG BARANGAY VIVIAN GAWARAN RAMIREZ OF BARANGAY ZAPOTE 1, BACOOR CITY, CAVITE AGAINST BARANGAY KAGAWAD ANGELITO DELA CRUZ OF THE SAME BARANGAY DUE TO THE AMICABLE SETTLEMENT OF THE SAID DISPUTE.

WHEREAS, on 7 July 2026, Punong Barangay Vivian Gawaran Ramirez of Barangay Zapote 1, Bacoor City, Cavite (complainant) filed an administrative complaint against Barangay Kagawad Angelito Dela Cruz of the same barangay (respondent) for alleged violation of Republic Act No. 6713 (Code of Conduct and Ethical Standards for public Officials and Employees).

WHEREAS, on 13 July 2026, the said matter was referred to the Committee on Ethics, Appointments and Government Re-organization for investigation.

WHEREAS, on 23 July and 3 September 2026, the said Committee conducted two (2) committee hearings during which the parties agreed to amicably settle their differences and they jointly moved for the dismissal of the said complaint.

NOW THEREFORE, upon motion of Councilor Miguel N. Bautista, duly seconded by the rest of the Body **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled to **DISMISS** the complaint above-mentioned due to the amicable settlement of the said dispute.
