A RESOLUTION COMMENDING AND RECOGNIZING THE EXEMPLARY PERFORMANCE OF PERSONNEL OF THE BACOR COMPONENT CITY POLICE STATION WHO ACTIVELY PARTICIPATED IN THE PROMPT AND EFFICIENT INVESTIGATION OF REPORTED VIOLATIONS OF VARIOUS LAWS ON 22 NOVEMBER 2025 AT BARANGAY TALABA 3, BACOR CITY, CAVITE.

WHEREAS, on 22 November 2025, three residents of the City of Bacoor, Cavite who were barely out of their teens reported to the Bacoor City Police that fourteen (14) Philippine National Police (PNP) Drug Enforcement Group personnel belonging to the Special Operations Unit of the Police Regional Office IV-A stationed at Camp Vicente Lim, Mayapa, Calamba City, Laguna allegedly violated Republic Act No. 8353 (the Anti-Rape Law), Republic Act No. 10883 (the New Anti-Carnapping Act of 2015) and Article 296 in relation to Articles 294 and 295 of the Revised Penal Code (Robber in Band).

WHEREAS, through the exemplary and concerted efforts of the following personnel of the Bacoor Component Police Station, the said perpetrators were arrested and the appropriate criminal complaints against them were filed on 23 November 2025 before the Office of the City Prosecutor of the City of Bacoor, Cavite:
