WHEREAS, on 9 December 2025, the Sangguniang Panlungsod received an endorsement letter from the Office of the City Mayor requesting the City Council to pass a resolution approving City Development Council (CDC) Resolution No. 11 with regard to its request to the Provincial Development Council (PDC) to endorse the infrastructure projects of the City of Bacoor to the CALABARZON Regional Development Council (RDC) for possible funding amounting to Four Billion Three Hundred Fifty-Nine Million and Seventy Thousand Pesos (Php4,359,070,000.00). The said CDC Resolution is incorporated hereto and will be made a part of this Resolution as **Annex "A"**.

CDC RESOLUTION No. 11 Series of 2025

A RESOLUTION REQUESTING THE CAVITE PROVINCIAL DEVELOPMENT COUNCIL (PDC) TO ENDORSE THE INFRASTRUCTURE PROJECTS OF THE CITY OF BACOR TO THE CALABARZON REGIONAL DEVELOPMENT COUNCIL (RDC) FOR POSSIBLE FUNDING AMOUNTING TO FOUR BILLION THREE HUNDRED FIFTY-NINE MILLION AND SEVENTY THOUSAND PESOS AND ZERO CENTAVO (PHP4,359,070,000.00)

WHEREAS, the City of Bacor recognizes the importance of sustainable urban development, disaster risk reduction, and climate resilience through implementation of infrastructure projects that foster urban growth, safeguard public welfare, protect the livelihoods of its constituents, and ensure an efficient flood management system within the locality;

WHEREAS, the City of Bacor has historically been highly susceptible to flooding due to its geographic characteristics as a low-lying coastal area and proximity to Bacor Bay, Imus River, and other waterways which further increase its vulnerability to surface runoff, river overflow, and tidal backflow;

WHEREAS, rapid urbanization has significantly increased surface runoff by reducing ground absorption capacity, and severely clogged, outdated, and insufficient drainage systems hinder efficient water flow throughout the City;

WHEREAS, the aforementioned contributing factors, coupled with the increasing frequency and intensity of extreme weather events brought about by climate change, expose the City of Bacor to high flood vulnerability which causes repeated damage to homes, infrastructure, and local businesses, disrupting mobility and economic productivity across multiple barangays, particularly those in coastal and low-lying areas;

WHEREAS, to mitigate the City's vulnerability to flooding and strengthen its adaptive capacity, the City Development Council (CDC) of Bacor has identified necessary flood mitigation and drainage improvement projects that require funding assistance from other government agencies for implementation;

WHEREAS, these projects are consistent with the National Disaster Risk Reduction and Management Framework, the National Framework Strategy on Climate Change, and the Sustainable Development Goals (SDGs);

WHEREAS, to strengthen flood mitigation and drainage infrastructure across the City of Bacor, the following priority projects have been identified:

CDC RESOLUTION No. 12 Series of 2025

A RESOLUTION EXPRESSING SUPPORT FOR THE CITY OF BACOR SMART CITY PROJECT AND RECOMMENDING ITS CONTINUED DEVELOPMENT AND IMPLEMENTATION IN COORDINATION WITH RMS CONSULTING, RMS PLATFORM, DOHWA ENGINEERING, AND YONSEI UNIVERSITY UNDER THE K-CITY NETWORK GLOBAL COOPERATION PROGRAM

WHEREAS, the City of Bacor has embarked on the formulation and advancement of its Bacor City Smart City Master Plan in line with its vision of promoting sustainable, inclusive, resilient, and technology-driven urban development, and in furtherance of its strategic goal to improve governance efficiency, disaster preparedness, infrastructure planning, and public service delivery through smart city initiatives;

WHEREAS, the City Government of Bacor formally applied for project preparation support under the 2024 K-City Network Global Cooperation Program of the Ministry of Land, Infrastructure and Transport of the Republic of Korea for the Target Project known as the "Bacor City Smart City Master Plan Project", covering smart city planning and smart solution planning components;

WHEREAS, pursuant to the said application and cooperation framework, the City of Bacor has engaged and collaborated with the following Korean institutions and cooperative, and Yonsei University, which have undertaken, among others, status surveys and analysis, smart city strategy development, ICT and platform planning, preliminary surveys, pre-feasibility studies, and technical assessments in connection with the Smart City Project;

WHEREAS, RMS Consulting has conducted comprehensive assessments and strategic studies, including business proposal development, review of relevant plans, and formulation of smart city promotion strategies, while RMS Platform has focused on ICT and platform planning and smart solution integration for the identified Bacor City development area, particularly the Bacor City New 35-Hectare Property;

WHEREAS, DOHWA Engineering has undertaken preliminary surveys and Urban plan reviews, and Yonsei University has provided technical pre-feasibility analysis and capacity-building support through invitational training programs to strengthen the technical foundation of the Smart City Master Plan;

WHEREAS, the City Planning and Development Coordinating Office (CPDC), as the primary planning arm of the City Government, recognizes the strategic importance of the Smart City Project in addressing critical urban challenges such as traffic congestion, disaster risk management, environmental sustainability, and service delivery optimization, while enhancing the city's competitiveness and investment attractiveness;

WHEREAS, the successful implementation of the Bacor City Smart City Project requires sustained institutional coordination, policy alignment, and endorsement at both local and regional levels, including support from the Regional Development Council IV-A and other relevant oversight bodies;

NOW WHEREFORE, upon motion of Hon. Rogelio M. Nolasco, Chairman Committee on Finance & Budget Appropriations, Sangguniang Panlungsod and duly seconded by Ms. Amy Famisan of Federation of Salinas Urban Homeowners Association, Inc., representing the CSOs/NGOs members of Full Council and all members present on regular CDC meeting assembled, be it:

1. EXPRESS FULL SUPPORT for the continued development and implementation of the Bacor City Smart City Project and its associated Smart City Master Plan in coordination with RMS Consulting, RMS Platform, DOHWA Engineering, Yonsei University, and other partner institutions under the K-City Network Global Cooperation Program.

2. RECOMMEND the sustained engagement of the technical partners in the refinement, operationalization, and future phases of the Smart City Project, including feasibility studies, pilot implementation, and capacity - building initiatives.
3. AFFIRM the role of the CPDC as lead coordinating office for planning integration, policy harmonization, and inter-agency collaboration relative to the Smart City Project, ensuring coherence with existing land use plans, development frameworks, and regional strategies.
4. URGE concerned local government departments and offices to extend full cooperation and technical support in the implementation of programs, studies, and activities related to the Smart City Project.
5. DIRECT that copies of this Resolution be furnished to the Office of the City Mayor, the Provincial Development Council Regional Development Council IV-A, RMS Consulting, RMS Platform, and all concerned agencies for their information, guidance, and appropriate action
