A RESOLUTION AUTHORIZING ENGR. ARTHUR SAN JOSE OF THE CITY ZONING AND LAND DEVELOPMENT DEPARTMENT TO INITIATE AND FACILITATE THE CORRECTION OF ENTRIES OF ALL PROPERTIES IN THE CITY OF BACOOR, PROVINCE OF CAVITE.

WHEREAS, on 8 January 2026, the City Administrator's Office requested the Sangguniang Panlungsod to pass a resolution authorizing Engr. Arthur San Jose of the Zoning and Land Development Department to initiate and facilitate the correction of entries of all properties in the City of Bacoor, Province of Cavite;

WHEREAS, on 28 March 2023, the Sangguniang Panlungsod of the City of Bacoor enacted City Ordinance No. 275-2023 otherwise known as the "Barangay Merger and Reorganization Ordinance of the City of Bacoor", which merged and renamed certain barangays in the City of Bacoor;

WHEREAS, on 8 May 2023, the Sangguniang Panlungsod of the City of Bacoor enacted City Ordinance No. 282-2023 approving various barangay resolutions supporting the merger and renaming of the Forty Seven (47) barangays in the City of Bacoor, Province of Cavite pursuant to City Ordinance No. 275-2023;

WHEREAS, on 23 October 2023, the Sangguniang Panlungsod of the City of Bacoor enacted City Ordinance No. 320-2023, otherwise known as the "2023 Barangay Political Boundaries Settlement Ordinance of the City of Bacoor", which effectively settled the political boundaries of the barangays comprising the City of Bacoor;

WHEREAS, some properties were nevertheless displaced from their original location as appearing in public record or document;

WHEREAS, among other effects of such barangay settlement is that all taxes and fees that should be paid by residents, real property owners and by business owners within each barangay shall be collected by the Barangay having jurisdiction over the corresponding residence, property, or business establishment;

WHEREAS, notwithstanding the foregoing, there appears to be inconsistencies in certain records of the City Government of Bacoor which are used as reference for the proper collection, allocation and/or distribution of public funds to the concerned barangay having jurisdiction over the subject of taxation;

WHEREAS, in the exercise of the oversight powers of the Sangguniang Panlungsod and in order to remediate any variance in public records, the Sangguniang Panlungsod unanimously decided to direct Engr. Arthur San Jose of the City Zoning and Land Development Department to initiate and facilitate the correction of entries of all properties in the City of Bacoor.

NOW THEREFORE, upon motion of Councilor Horacio M. Brillantes, Jr., unanimously seconded by the members of the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Engr. Arthur San Jose of the City Zoning and Land Development Department to initiate and facilitate the correction of entries of all properties in the City of Bacoor, Province of Cavite by issuing a certification and/or recommendation to the concerned department/unit for their appropriate and timely action.

RESOLVED FURTHER, that all certification and/or recommendation issued for the month shall be submitted to the Sangguniang Panlungsod by Engr. San Jose every first working day of the following month.

RESOLVED LASTLY, to furnish the Office of the City Mayor, Engr. San Jose, and all government agencies concerned with copies of this Resolution.
