A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT AMONG THE CITY GOVERNMENT OF BACOOR, G-XCHANGE, INC. AND NEO-CONNECT ICT SOLUTIONS, INC.

WHEREAS, the Sangguniang Panlungsod received a letter from the City's Administrator's Office requesting that a resolution be passed authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement (MOA) among the City Government of Bacoor, G-Xchange, Inc. and Neo-Connect ICT Solutions, Inc. (NCIS).

WHEREAS, on 3 October 2025, the NCIS entered into a MOA with the City Government of Bacoor to support the contactless implementation of the city's various programs by digitally extending financial assistance, livelihood grants and other social services to qualified residents of Bacoor City at no cost to the city government.

WHEREAS, the NCIS will provide premium service involving the development and operation of a secured digital platform that will facilitate the following:

- a. Registration, whether online or offline, of City Government of Bacoor and residents of the city who are qualified to receive the benefits of the said program/s;
- b. Submission of digital copies of supporting documents is required for registration and eligibility verification;
- c. Issuance of both a virtual and physical card to enable the disbursement of electronic money (e-

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement (the "Agreement") is made and executed this ____ day of _____ 2025 (the "Effective Date"), in _____, by and between:

NEO-CONNECT ICT SOLUTIONS, INC., (formerly Neo-Converge ICT Solutions, Inc.), a corporation duly organized and existing under and by virtue of Philippine laws, with principal office address at Unit 5A, OPL Building, 100 C. Palanca Street, Legaspi Village, Makati City, represented herein by its President, **ARISTOTELES Z. ELVINA**, and hereinafter referred to as "NCIS"

and

G-XCHANGE, INC., a corporation duly organized and existing under and by virtue of Philippine laws, with business address at 8th Floor, W Global Center, 39th Avenue corner 30th Street, Bonifacio Global City, 1634 Taguig City, Metro Manila, Philippines, represented herein by its Vice President, Head of Public Sector, **CLEO CELESTE C. SANTOS**, and hereinafter referred to as "GXI"

and

The **CITY GOVERNMENT OF BACCOOR**, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with its principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, **Hon. STRIKE B. REVILLA**, pursuant to his authority conferred and embodied in City Resolution No. _____, Series of 2025, approved by the City Council of Bacoor dated _____, and hereinafter referred to as "LGU BACCOOR"

NCIS, GXI and LGU BACCOOR shall be collectively referred to as the "Parties" and individually as a "Party," if applicable.

WITNESSETH:

WHEREAS, NCIS entered into a Memorandum of Agreement dated 3 October 2025 (the "MOA") with LGU BACCOOR;

WHEREAS, to support the LGU BACCOOR in the "contactless" implementation of its various programs designed to extend financial assistance,

livelihood grants, and other social services to qualified residents of the City of Bacoor (hereinafter referred to as the "Programs"), the MOA provides that NCIS shall provide, at no cost to LGU BACOOR, a premium service involving the development and operation of a secured digital platform that shall facilitate the following:

- a. Registration, whether online or offline, of LGU BACOOR and residents of the city who are qualified to receive the benefits of the Programs;
- b. Submission of digital copies of supporting documents is required for registration and eligibility verification;
- c. Issuance of both a virtual and physical card to enable the disbursement of electronic money (e-money) to LGU BACOOR employees and qualified Program beneficiaries; and
- d. Inclusion of qualified taxpayers and business establishments eligible to receive benefits of the Programs.

WHEREAS, Section 1.B of the MOA provides that: "NCIS may perform any or all of its obligations under this Agreement in partnership, consortium, or collaboration with third parties, subject to applicable laws, rules, and regulations, and provided that such third parties are not, and have not been blacklisted or disqualified by any governmental authority. NCIS may likewise engage and designate subcontractors to carry out any portion of its obligations under this Agreement, subject to the same legal and regulatory conditions, and provided that such subcontractors are likewise not, and have not been, blacklisted by any governmental agency or instrumentality. For clarity, any such partnership, consortium, or subcontracting arrangement shall not relieve NCIS of its primary responsibility and full liability for the proper, timely, and lawful performance of its obligations under this Agreement."

WHEREAS, GXI is a duly licensed and registered remittance agent and e-money issuer. It is also a mobile payment solutions provider using the network of its parent company, Globe Telecom, Inc., as transport channel under the GCash brand.

WHEREAS, the Parties are entering into this Agreement to confirm the performance of certain obligations by GXI in relation to the MOA, specifically as it pertains to the issuance of physical cards to enable the disbursement of electronic money (e-money) to LGU BACOOR employees and qualified Program beneficiaries;

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual covenants and undertakings herein set forth, the Parties hereby agree to be bound by the following terms and conditions:

1. The Parties hereby agree and confirm that in relation to the obligations of NCIS under Section 1.A. of the MOA, NCIS shall perform its obligation to issue the physical Strike Cards capable of facilitating electronic payments from both online and offline transactions, through GXI.

2. This Agreement shall not relieve NCIS of its primary responsibility and full liability for the proper, timely, and lawful performance of its obligations to LGU BACOOR under the MOA.

3. This Agreement shall be effective as of the Effective Date and its term shall be co-terminus with the term of the MOA.

4. In case of conflict between the interpretation and/or implementation of the provisions of the MOA and this Agreement, the MOA shall govern.

5. This Agreement may be executed and delivered in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.

IN WITNESS WHEREOF, the parties, through their duly authorized representatives, have executed this Agreement as of the date and at the place set forth above.
