CITY RESOLUTION NO. 2026-947  
Series of 2026

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN SITIO KAWAYANAN, BARANGAY TALABA 2, CITY OF BACOOR, CAVITE DUE TO MASSIVE PROPERTY DAMAGE CAUSED BY THE FIRE THAT BROKE OUT ON 30 JANUARY 2026 AND TO AUTHORIZE THE CITY MAYOR, HONORABLE STRIKE B. REVILLA, TO DISBURSE THE AMOUNT OF TWO MILLION PESOS (PHP 2,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED AS QUICK RESPONSE FUND FOR RELIEF GOODS AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out on 30 January 2026 at around 1:15 in the morning at Barangay Talaba 2, City of Bacoor, Cavite.

WHEREAS, the Initial Disaster Report dated 30 January 2026 submitted by Ms. Emiliana DR. Ugalde, Head of the City Social Welfare and Development Department, showed that around 80 families were affected by the said conflagration.

WHEREAS, the same report stated that the homes and personal belongings of the same families were destroyed by the fire.

WHEREAS, in the afternoon of 30 January 2026, the City Disaster Risk Reduction and Management Council of the City of Bacoor, Cavite passed its Resolution No. 01, Series of 2026 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Sitio Kawayanan, Barangay Talaba 2, City of Bacoor, Cavite due to massive property damage caused by the fire that broke out that morning and to authorize the City Mayor, Honorable Strike B. Revilla, to disburse the amount of Two Million Pesos (Php 2,000,000.00) from the Disaster Risk Reduction and Management Fund to be used as
