**WHEREAS**, on 17 March 2026, the Local Health Board issued Resolution No. 02-2026 entitled: "A Resolution Authorizing The City Government Of Bacoor To Open An Account With The Landbank Of The Philippines Under The Account Name "City Government Of Bacoor PHILHEALTH Trust Fund".

**WHEREAS**, there is a need to establish a dedicated bank account for the efficient handling of PHILHEALTH funds that are downloaded to the City Government;
