Excerpts from the minutes of the 52ND Regular Session held last February 2, 2026 at the session hall of Barangay Queen's Row Central, City of Bacoor, Cavite.

BARANGAY RESOLUTION NO. 31
Series of 2026

A RESOLUTION ADOPTING AND SUPPORTING KAAGAPAY HOMEOWNER'S ASSOCIATION (KHOA) BOARD RESOLUTION NO. 001, SERIES OF 2026, IMPLEMENTING A "ONE-WAY TRAFFIC SCHEME," "ONE-SIDE PARKING," AND "NO PARKING/NO OBSTRUCTION" POLICY WITHIN THE KAAGAPAY SUBDIVISION

WHEREAS, the Kaagapay Homeowner's Association, Inc. (KHOA) has the primary duty to maintain order, safety, and the welfare of all residents within the subdivision;

WHEREAS, due to narrow roads, the frequent meeting of vehicles and lack of an organized parking system have caused significant inconvenience, danger, and obstruction to traffic flow;

WHEREAS, the KHOA Board of Directors, led by President Ms. Liezel C. Pedrosa, formally approved Board Resolution No. 001 on January 11, 2026, to address these issues;

WHEREAS, the Sangguniang Barangay recognizes that these policies are essential to ensure the swift response of emergency vehicles, such as fire trucks and ambulances, and the unhindered entry of service vehicles like garbage trucks;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Barangay officially adopts and authorizes the enforcement of the following rules within Kaagapay Subdivision:

- **One-Way Traffic Scheme:** Kaunlaran St. shall serve as the Main Entrance, while Pinagbuklod St. shall serve as the Main Exit.
- **One-Way Streets:** Pag-asa St., Pagkakaisa St., and Palabrica St. are designated as one-way streets following a left-turn flow from the main access road.
- **One-Side Parking:** This shall be implemented on Pag-asa St., Pagkakaisa St., and Palabrica St. in areas designated by the association.
- **No Parking/No Obstruction:** A strict policy shall be enforced on both sides of Kaunlaran St. and Pinagbuklod St. to maintain clear traffic passage.


RESOLVED FINALLY, that this policy shall take effect on February 8, 2026, following a period of information dissemination to all residents.
