CITY RESOLUTION NO. 2026-990

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN TABING ILOG ST., SITIO BANALO, BARANGAY SINBANALI AND TRAMO ST., BARANGAY ZAPOTE 2, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

**WHEREAS**, a fire broke out in a residential unit at Tabing Ilog St., Sitio Banalo, Barangay Sinbanali in the early morning of March 19 2026, that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 62 families whose houses were destroyed.

**WHEREAS**, at Tramo St., in Barangay Zapote 2, City of Bacoor, Cavite on the same day, a fire broke out in the afternoon that rapidly spread to adjacent commercial and residential units affecting 75 families whose houses were also destroyed.

**WHEREAS**, the Bacoor City Disaster Risk Reduction and Management Council (CBDRPMC) passed Resolution No. 05, Series of 2026 dated March 20, 2026, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Zapote 2 and Barangay Sinbanali, City of Bacoor, Cavite and authorizing the release of **Five Million Pesos (Php 5,000,000.00)** from the City Disaster Risk Reduction and Management Fund to be used for financial assistance, relief goods, and other incidental expenses related to relief and rehabilitation operations.

**WHEREAS**, a copy of the said CBDRPMC Resolution No. 05, Series of 2026 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.
