with the said sale pursuant to City Resolution No. 2026-933 dated 19 January 2026.

**WHEREAS**, on 18 March 2026, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod to pass a Resolution authorizing that the proceeds from the sale of the said parcels of land be deposited back to the Socialized Housing Trust Fund of the City Government which was the source of the funds that were used for the purchase of the said properties by the City Government.

**WHEREAS**, the City Mayor also requested the Sangguniang Panlungsod in the same letter to authorize the deposit of Php5,000,000.00 to the Socialized Housing Trust Fund of the City Government as the said amount represents the expenditures related to the cost of architectural and civil works already done by the City Government on Salinas properties at the time they were sold to PH1 World Landscapes Inc. The said amount was reimbursed by PH1 World Landscapes Inc. in favor of the City Government upon the consummation of the said sale.

**WHEREAS**, the purpose of the said requests, according to the City Mayor, is to ensure transparency and accountability in the handling of public funds and to ensure that the proceeds from the sale of the said assets are reinvested in initiatives that directly benefit the socialized housing program of the City Government.

**WHEREAS**, a series of hearings were conducted by the standing committees of the Sangguniang Panlungsod and it was recommended by the members of the said committees that the requests of the City Mayor be approved.

**NOW THEREFORE**, upon motion of Hon. Rogelio Nolasco, unanimously seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the deposit of the proceeds from the sale of City Government owned lands in Barangay Dulong Bayan, Bacoor City, Cavite and the reimbursement of expenditures for the development of the property in Barangay Salinas 1 amounting to Php 5,000,000.00 to the Socialized Housing Trust Fund of the City of Bacoor, Cavite.
