



BARANGAY ORDINANCE NO. 01-2026 Series of 2026

AN ORDINANCE ADOPTING AND ENFORCING CITY ORDINANCE NO. 246-2022, OTHERWISE KNOWN AS THE "PREEMPTIVE AND FORCE EVACUATION ORDINANCE OF BACOOR," MANDATING PREEMPTIVE AND FORCED EVACUATIONS DURING DISASTERS WHERE DESTRUCTION OF PROPERTY OR LOSS OF LIVES IS IMMINENT.

WHEREAS, Section 16 of the Local Government Code of 1991 (RA 7160) mandates that every local government unit shall exercise powers essential to the promotion of the general welfare and safety of its inhabitants;

WHEREAS, the City Government of Bacoor enacted City Ordinance No. 246-2022 on November 18, 2022 to provide a legal framework for mandatory evacuations to ensure public safety during life-threatening calamities.

WHEREAS, there is a need for Barangay Salinas 2 to formally adopt these guidelines to empower the Barangay Disaster Risk Reduction and Management Committee (BDRRMC) to initiate evacuations effectively;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Barangay of Salinas 2, Bacoor City, in session assembled;

SECTION 1. ADOPTION. City Ordinance No. 246-2022 of the City of Bacoor, including its Implementing Rules and Regulations (IRR), is hereby adopted in its entirety.

SECTION 2. ENFORCEMENT. The BDRRMC – Response Team shall be the primary unit responsible for implementing preemptive and forced evacuations when danger to life or property is imminent.

SECTION 3. PROCEDURES. The barangay shall follow the city-mandated protocols, including:

- Early Warning: Use of emergency sirens and public address systems as prescribed by the city.
- Evacuation Centers: Ensuring all displaced citizens are secured in pre-determined and conducive evacuation centers.

SECTION 4. PENALTIES. Violations of this ordinance, specifically the refusal to evacuate after a forced evacuation has been declared, shall be subject to the penalties, under Local Government Code limits the maximum fine a Barangay can independently impose to P 1,000.00 for higher penalties or imprisonment, the case is referred to the City legal system provided under City Ordinance No. 246-2022 and other relevant laws, such as RA 10121 (The Philippines DRRM Act)."
