AN ORDINANCE ADOPTING CITY ORDINANCE NO. 11-2015 AND CITY ORDINANCE NO. 262-2023, PROHIBITING THE SALE, VENDING, SERVING AND DISTRIBUTION OF LIQUOR AND OTHER INTOXICATING BEVERAGES TO MINORS WITHIN THE JURISDICTION OF BARANGAY SALINAS 2

WHEREAS, Section 16 of Republic Act 7160 (Local Government Code of 1991) mandates that Local Government Units shall ensure and support the promotion of health and safety, and improve public morals;

WHEREAS, The City Government of Bacoor has enacted City Ordinance No. 11. 11-2015 (Prohibiting the sale of liquor to minors) and City Ordinance No. 262-2023 (Liquor Sale Regulation Ordinance), which strictly regulate the distribution of alcoholic drinks to protect the youth;

WHEREAS, the Sangguniang Barangay of Salinas 2 recognizes the need to localize these measures to ensure strict compliance by sari-sari stores, convenience stores, and establishments within its territorial jurisdiction;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF SALINAS 2, CITY OF BACCOOR, IN SESSION ASSEMBLED:

SECTION 1. PROHIBITED ACTS. It shall be unlawful for any person, business owner, or establishment within Barangay Salinas 2 to:

1. Sell, serve, or distribute any form of liquor, wine, or intoxicating beverages to any person under eighteen (18) years of age (Minors).
2. Allow minors to consume alcoholic beverages within their business premises or in any public place.
3. Allow adults to use minors as "couriers" or "errands" to purchase liquor.

SECTION 2. MANDATORY SIGNAGE. All establishments selling liquor must display a visible sign (at least 8.5 x 11 inches) stating: **"STRICTLY NO SELLING OF LIQUOR TO MINORS."**

SECTION 3. PENALTIES. Any person or establishment found violating this ordinance shall be subject to the following:

- **1st offense:** Reprimand and a fine of Five hundred Pesos (P500.00).
- **2nd offense:** Fine of One Thousand Pesos (P 1,000.00) and recommendation to the City Mayor for the suspension/revocation of Business Permit.

SECTION 4. ENFORCEMENT. The Barangay Tanods, members of the Lupon Tagapamayapa, and Barangay Officials are hereby authorized to monitor compliance and report violators to the Bacoor City Police.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared unconstitutional or invalid, the remaining parts shall remain in full force and effect.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon approval and posting in three (3) conspicuous places within the Barangay.

SECTION 7. PARENTAL RESPONSIBILITY. In accordance with City Ordinance No. 171-2021, parents or guardians of minors caught violating this ordinance shall be held liable:

- **First Apprehension:** The minor shall be returned to their residence, and the parents/guardians shall receive a formal warning.
- **Succeeding Violations:** Parents or guardians shall be required to pay a fine of Five hundred pesos.
- **Mandatory Seminar:** Parents and minors may be required to attend a seminar on the hazards of intoxicating beverages conducted by the City.


