

CITY ORDINANCE NO. 289-2023 Series of 2023** "AN ORDINANCE REVOKING ALL LETTERS OF NO OBJECTION ISSUED BY THE LOCAL GOVERNMENT OF THE CITY OF BACoor, CAVITE TO OPERATORS OF E-BINGOS, E-GAMES, AND SIMILAR BETTING PLATFORMS FOUND TO HAVE VILATED RELEVANT NATIONAL LAWS OR LOCAL ORDINANCES, IMPOSING STRICTER REGULATORY REQUIREMENTS, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.
