WHEREAS, after having been reviewed by the committee, it was found that the said ordinance shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations;

WHEREAS, the submitted supplemental budget is hereby recommended to be operative in its entirety, effective on the date of its approval, subject to the posting requirement under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The savings certified available by the City Treasurer and City
 Accountant for supplemental appropriation are free of any
 obligations or encumbrances and/or are still available after
 the satisfactory completion or the unavoidable
 discontinuance or abandonment of the work, activity or
 purpose for which the appropriations were originally
 authorized;
- The appropriation in the amount of P2,437,270.00 for Overtime and Night Pay shall be in accordance with CSC-DBM Joint Circular No. 1- 2015 dated 25 November 2015 (Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees);
- The appropriation in the amount of P2,500,000.00 for Terminal Leave Benefits is subject to Budget Circular No. 2016-2 dated 29 March 2016 (Guidelines on Terminal Leave Benefits & Monetization of Leave Credits);
- The appropriation in the amount of P5,000,000.00 for Traveling-Foreign is subject to Executive Order No. 77 dated 15 March 2019 (Prescribing Rules and Regulations and Rates of Expenses and Allowances for Official Local and Foreign Travels of Government Personnel);
- 5. The appropriation in the amount of P1,000,000.00 for Debt Service shall be in accordance with Section 324 (b) of R.A. No. 7160 which requires that "Full provision shall be made for all statutory and contractual obligations of the local government unit concerned: provided, however, that the amount of appropriations for the servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned";
