WHEREAS, after having been reviewed by the committee, it was found that the said ordinance shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations;

WHEREAS, the submitted supplemental budget is hereby recommended to be operative in its entirety, effective on the date of its approval, subject to the posting requirement under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. *The savings certified available by the City Treasurer and City Accountant for supplemental appropriation are free of any obligations or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;*
2. *The appropriation in the amount of P5,000,000.00 for Terminal Leave Benefits is subject to Budget Circular No. 2016-2 dated 29 March 2016 (Guidelines on Terminal Leave Benefits & Monetization of Leave Credits);*
3. *The appropriation in the amount of P16,000,000.00 for Debt Service shall be in accordance with Section 324 (b) of R.A. No. 7160 which requires that "Full provision shall be made for all statutory and contractual obligations of the local government unit concerned: provided, however, that the amount of appropriations for the servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned";*
4. *The appropriation for Donation in the amount of P15,000,000.00 shall be subject to Sec 335 of the Local Government Code, which provides that "No public money or property shall be appropriated or applied for religious or private purposes";*
5. *The procurement of supplies, materials, equipment and infrastructure projects, as the case may be, shall strictly comply with the provisions of R. A. No. 9184 and its Revised IRR and any relevant policies issued by the Government Procurement Policy Board (GPPB).*
