Our office is appropriately forwarding the following Resolutions and Ordinances we received when the **Hon. Rowena Bautista-Mendiola** assumed as Acting Mayor on August 29, 2023 to September 22, 2023 as appointed by City Mayor the **Hon. Strike B. Revilla**, thru Memorandum No. 44-A Series of 2023.

1. City Resolution No. 2023-334, Series of 2023 entitled: **"A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOR TO APPLY, NEGOTIATE AND ENTER INTO A LOAN AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES AND TO SIGN, ENDORSE, EXECUTE LOAN DOCUMENTS, AMENDMENTS TO LOAN AGREEMENTS AND EXECUTE SUCH AGREEMENTS, CONTRACTS, DEEDS, PAPERS, PROMISSORY NOTES AND OTHER RELATED DOCUMENTS FOR THE FOLLOWING PROJECTS, TO WIT: A) ONE HUNDRED SIXTY-SEVEN MILLION SEVEN HUNDRED TWENTY-SEVEN THOUSAND NINE HUNDRED PESOS (PHP167,727,900.00) FOR LOT ACQUISITION; (B) TO TAKE-OUT THE OUTSTANDING LOAN BALANCE AND FINANCE THE UNAVAILED PORTION OF THE LOAN AND OTHER CHARGES FROM THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF: (i) FOUR HUNDRED SIXTY MILLION PESOS (PHP460,000,000.00) FOR THE CONSTRUCTION OF THE BACOR DISASTER RISK BUILDING, (ii) SEVENTY MILLION PESOS (PHP70,000,000.00) FOR THE ACQUISITION OF FURNITURE AND FIXTURES FOR THE BACOR DISASTER RISK BUILDING, AND; (C) OMNIBUS TERM LOAN FACILITY IN THE AMOUNT OF ONE BILLION PESOS (PHP1,000,000,000.00)";**
2. City Ordinance No. 304-2023, Series of 2023 entitled: **"ISANG ORDINANSA NA NAG-AAMYENDA SA PLANTILLA NG BACOR BARANGAY AFFAIRS OFFICE UPANG MAPAIPATUPAD NG MAS MAAYOS ANG IBA'T IBANG ORDINANSA NG PAMAHALAANG LUNGSOD NG LUNGSOD NG BACOR, CAVITE";**
3. City Resolution No. 2023-328, Series of 2023 entitled: **"A RESOLUTION AUTHORIZING THE ACTING CITY MAYOR, HON. ROWENA BAUTISTA – MENDIOLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH FILINVEST LAND, INC – MAINSQUARE MALL FOR THE ESTABLISHMENT OF A "SOLIDARITY ROUTE STICKER (SRS) INSTALLATION HUB" AT THE MAINSQUARE MALL PREMISES"; and**
4. City Resolution No. 20230-329 Series of 2023 entitled: **"A RESOLUTION AUTHORIZING THE PROCUREMENT OF THREE (3) FIRETRUCKS, ONE (1) VAN, AND ONE (1) HEAVY CARGO TRUCK FOR THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT**
