City Ordinance No. 383-2024 – An Ordinance Authorizing The City Mayor, Hon. Strike B. Revilla, To Initiate The Filing Of Expropriation Proceedings For And On Behalf Of The City Government Of Bacoor, Cavite, Through The Office Of The City Legal Service To Acquire The 1,132-Square Meter Portion Of The Parcel Of Land Covered By TCT No. 1278707 Registered Under The Name Of VAA Builders Corporation And All Persons Claiming Rights Under Them And The 3,874-Square Meter Portion Of The Parcel Of Land Covered By TCT No. 167-2018000559 Registered Under The Name Of JGHM 5386A Realty Corporation And All Persons Claiming Rights Under Them For The Establishment Of A Road Right Of Way And The Construction Of A Public Road And Appropriating The Necessary Funds Therefor And Other Purposes

WHEREAS, after having been reviewed by the said Committees and the Office of the Provincial Legal Officer, it was recommended for approval;

The subject Ordinance is consistent with applicable laws and regulations. Pursuant to Section 19 in relation to Section 458(a)(6) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991 (LGC)" the Sangguniang Panlungsod, as the legislative body of the city, may exercise other powers and perform duties and functions as prescribed by law or ordinance, which include authorizing the local chief executive, on behalf of the local government unit, to exercise the power of eminent domain or to pursue expropriation proceedings over a particular private property.

It should be noted that Section 19 of the same law provides that the power of eminent domain may not be exercised unless a valid and definite offer has been previously made to the owner, and such offer was not accepted. Provided, further, that the local government unit may immediately take possession of the property upon the filing of the expropriation proceedings and upon making a deposit with the proper court of atleast fifteen percent (15%) of the fair market value of the property based on the current tax declaration of the property to be expropriated. Provided, finally, that the amount to be paid for the expropriated property shall be determined by the proper court, based on the fair market value at the time of the taking of the property.

Likewise, the instant ordinance is also in accordance with Republic Act No. 10752, otherwise known as the "Right-of-Way Act", which provide rules on facilitating the acquisition of the Right-of-Way, site or location for National Government infrastructure projects.
