
#### A RESOLUTION APPROVING CITY ORDINANCE NO. 332-S-2023 FROM BACOOR CITY

Salazar, Chair, Committee on Rules & Good Government, pertaining to an ordinance from Bacoor City, entitled:

WHEREAS, upon review and careful study by the said committees and the Office of the Provincial Legal Officer, it was recommended for approval with minor modifications;

Section 17 of Republic Act No. 7160, otherwise known as the Local Govenrment Code of 1991 provides that the city shall provide basic services and facilities which include low-cost housing and other infrastructure facilities intended to service the needs of its residents. Likewise, Section 19 of the same law allows a local government, through its chief executive and acting pursuant to an ordinance, to exercise the power of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless.

However, these Committees would like to clarify the provisions of the Local Government Code of 1991 cited in the Whereas Clause.

1. In the second whereas clause, it should be Section 458 (a) which declares that the Sangguniang Panglungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants:

- In the fourth whereas clause, it should be Section 17(b)(4)(b) which states that the City Government shall provide public works and infrastructure projects and other facilities, programs and services;
- 3. In the twelve whereas clause, it should be Section 19 which states that the Local Government Unit may through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless, upon payment of just compensation.


