Page 2: EXCERPTS, 84th Regular Session March 25, 2024 Res. No. 3039-2024

Section 458 (a)(1)(ii) of Republic Act (R.A.) no. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances aimed in maintaining peace and order. Furthermore, it is empowered to impose penalties for violations of said ordinances for the general welfare of the city as provided for under Section 16 of this Code, and shall:

SECTION. 458 - Powers. Duties. **Functions** Compensation.- (a) The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

(3) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection, shall:

XXX

(i) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances:

The subject ordinance is also in accordance with the following:

- 1, Article 327 of Act No. 3815, also known as the Revised Penal Code, provides the similarity in the definition of Vandalism and Malicious Mischief, were both is committed by any person who shall deliberately cause to the property of another any damage not falling within the terms of Article 328 of the same law.
- Article 308 of the same law, provides that theft is committed by any person who, with intent to gain but without violence against or intimidation of persons nor force upon things, shall take personal property of another without the latter's consent.
- Section 57 of R.A. No. 10630, otherwise known as An Act Establishing a Comprehensive Juvenile Justice and Welfare System, Creating the Juvenile Justice and Welfare Council under the Department of Social Welfare and Development,

Appropriating Funds Thereof, and for Other Purposes, provides that, any conduct not considered an offense or not penalized if committed by an adult shall not be considered an offense and shall not be punished if committed by a child.

Furthermore, Section 57-A of the same law, provides violation of Local Ordinance enacted by local governments concerning juvenile status offenses such as, but not limited to, light offenses, misdemeanors against public order or safety, disorderly conduct, public scandal, vandalism and trespassing, shall be for the protection of children. Further, no penalty shall be imposed on children for said violations, and they shall instead be brought to their residence or to any barangay official at the barangay hall to be released to the custody of their parents.

Considering that the subject Ordinance contained penal sanctions, the same shall be posted and published in compliance with Section 511 of R. A. no. 7160, in order for it to be effective.
