The said transferring, creation, and abolition of positions may be allowed pursuant to Section 76 of RA 7160 (Local Government Code of 1991), which states that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability subject to the minimum standards and guidelines by the Civil Service Commission.

The creation of positions are also aligned with the DBM Local Budget Circular No. 137 s. 2021 issued on July 31, 2021. Nevertheless, it shall be ensured that all positions are vacant before their abolition.




