Page 2: EXCERPTS, 110th Regular Session September 30, 2024 Res. No. 3342-2024

Section 458(a)(3)(iii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances levying taxes, fees, and charges, and prescribe the terms and conditions under which public utilities owned by the city shall be operated by the city government or leased to private persons or entities, and for such purposes intended to promote the general welfare of the city's inhabitants.

Likewise, Section 129 of the same law provides that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy.

Further, the subject ordinance is also in accordance with the Department of the Interior and Local Government (DILG) and the Department of Finance (DOF) Joint Memorandum Circular (JMC) No. 2019-01 with the subject "Guidelines for the review, adjustment, setting, and/or adoption of reasonable regulatory fees and charges of Local Government Units."
