2. **City Ordinance No. 373-S-2024** – An Ordinance Regulating The Use, Sale, Distribution, And Advertisement Of Cigarettes And Other Tobacco Products Such As Electronic Cigarettes, Heated Tobacco Products And Other Nicotine/Non-Nicotine Delivery Devices, Imposing Penalties For Violations Hereof And Providing Funds Therefor.
3. **City Ordinance No. 374-S-2024** – An Ordinance Penalizing Any Individual Engaged In The Sale Or Distribution Of Fake Medical Products Within The City Of Bacoor, Cavite
4. **City Ordinance No. 377-S- 2024** – An Ordinance Prohibiting The Operation Of Remotely Piloted Aircrafts (RPAs) Or Unmanned Aerial Vehicles (UAVs), More Popularly Known As Drones, Within 100 Meters From The Bacoor City Jail And Other Detention Facilities Within The City Of Bacoor, Cavite, Providing Penalties For Violations Hereof, And For Other Purposes
