



**WHEREAS**, after having been reviewed by the said Committee with the technical assistance from the Office of the Provincial Budget Officer (OPBO), it was ascertained that the Appropriation Ordinance shows substantial compliance with the provisions of RA 7160 and its Implementing Rules and Regulations;

**WHEREAS**, the said Appropriation Ordinance is hereby recommended to be operative in its entirety effective on the date of its approval subject to the posting requirement under Section 59 and subject further to the following conditions:

1. The savings certified available by the City Treasurer and City Accountant for supplemental appropriation are free of any obligations or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
2. The appropriation in the amount of ₱100,000.00 intended for the payment of Honoraria shall be in accordance with BC NO. 2004-5 (Guidelines on the Grant of Honoraria to Government Personnel Involved in Government Procurement) dated March 23, 2004.
3. The appropriation for Donations in the amount of ₱17,000,000.00 shall be subject to Sec 335 of the Local Government Code, which provides that "No public money or property shall be appropriated or applied for religious or private purposes";
4. The total appropriation of ₱2,000,000.00 for Other Maintenance and Operating Expenses shall include only cost of services, which cannot be classified under any other account name and shall in no case be utilized or used for payment of salaries and/or other remunerations of personnel;
5. The procurement of supplies, materials and equipment, and services, as the case may be, shall strictly comply with the provisions of R. A. No. 9184 and its Revised IRR and any relevant policies issued by the Government Procurement Policy Board (GPPB).

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.
