Pursuant to Section 132 of Republic Act no. 7160 (R.A. No. 7160) otherwise known as the Local Government Code of 1991 (LGC), it provides that the power to impose a tax, fee, or charge or to generate revenue under this Code shall be exercised by the Sanggunian of the local government unit concerned through an appropriate ordinance.

Section 458(a)(2)(ii) of the same law provides that the Sangguniang Panlungsod, as the legislative body of the city, is given the powers, duties, and functions to generate and maximize the use of resources and revenues for the development plans, program objectives, and priorities of the city.

Section 458(a)(4)(ix) of the same law provides that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances and appropriate funds for the general welfare of the city and its inhabitants, regulating the establishment, operation, and maintenance of funeral parlors and the burial or cremation of the dead, subject to existing laws, rules, and regulations.

Further, the Department of the Interior Local Government (DILG) and the Department of Finance (DOF) issued a Joint Memorandum Circular (JMC) No. 2019-01 with the subject "Guidelines for the review, adjustment, setting and/or adoption of reasonable regulatory fees and charges of Local Government Units"

It should be noted that in the Bureau of Local Government Finance (BLGF) Memorandum Circular No. 20-2019, with the subject, "Local Fees and Charges (LFC) toolkit on the Review, Setting, and/or Adoption of Reasonable Local Fees and Charges." paragraph 5.2.7 provides that the concerned LGU office shall compare its current fee rates with the total cost of regulation or delivering the subject service, as estimated using the Toolkit. The acceptable marginal difference shall not be greater than or less than ten percent (10%) of the estimated actual cost of delivering the services. In case of greater than the 10% acceptable range, the LGU is encouraged to adopt the estimated cost from the LFC toolkit and adjust the fee schedule accordingly or improve service to the public, to wit:

"b. In case the result is above the 10% acceptable range, the imposition of the LGU is not reasonable. Hence, the LGU is encouraged to: (i) adopt the result of the estimated cost from LFC toolkit and revise its schedule of fees and charges, or (ii) provide better or much improved service to the public to justify the fee rate and commensurate to quality/efficiency of the service expected."




