

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides in part that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance;

WHEREAS, Section 468 (a) (1) of the same Act likewise provides in part that the Sangguniang Panlalawigan, as the legislative body of the province, shall approve ordinances and pass resolutions necessary for an efficient and effective provincial government and those which are essential to the promotion of the general welfare;

WHEREAS, during its 7th Special Session held on 31 July 2024, the 11th Sangguniang Panlalawigan of Cavite passed Resolution No. 3228-2024 entitled, "A Resolution Declaring A State Of Calamity In The Coastal Areas In The Province Of Cavite (Cities Of Cavite And Bacoor And Municipalities Of Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, And Ternate) Due To The Adverse Impact Of The Bataan Oil Spill And Authorizing Hon. Juanito Victor C. Remulla, Provincial Governor, To Utilize The Amount Of Fifteen Million Pesos (Php15,000,000.00) From The Quick Response Fund (QRF) Of The 2024 Provincial Disaster Risk Reduction And Management Fund (PDRRMF) To Effectively Respond To The Said Calamity".

WHEREAS, the Bureau of Fisheries and Aquatic Resources issued Bataan Oil Spill Bulletin No. 06, Series of 2024, declaring that fish and other seafood products in the Cities of Cavite and Bacoor and the Municipalities of Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, and Ternate are now safe for human consumption;

WHEREAS, it is deemed appropriate that the state of calamity previously declared in the coastal areas of the Province of Cavite (Cities of Cavite and Bacoor and Municipalities of Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, and Ternate) due to the adverse impact of Bataan oil spill be lifted;

NOW, THEREFORE, on motion of Hon. Ambion, duly seconded by Hon. Sison and unanimously approved by the Sangguniang Panlalawigan Members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that the state of calamity in the coastal areas of the Province of Cavite (Cities of Cavite and Bacoor and Municipalities of Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, and Ternate) due to the Bataan Oil Spill (SP Resolution No. 3228-2024) be lifted.






