WHEREAS, after having been reviewed by the said Committee with the technical assistance from the Office of the Provincial Budget Officer (OPBO), it was ascertained that the Appropriation Ordinance shows substantial compliance with the provisions of RA 7160 and its Implementing Rules and Regulations,

WHEREAS, the said Appropriation Ordinance is hereby recommended to be operative in its entirety effective on the date of its approval subject to the posting requirement under Section 59 and subject further to the following conditions:

- 1. The savings certified available by the City Treasurer and City Accountant for supplemental appropriation are free of any obligations or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
- The appropriation in the amount of ₱800,000.00 intended for the payment of Honoraria shall be in accordance with Budget Circular No. 2007-2 dated October 1, 2007 (Guidelines on the Grant of Honoraria Due to Assignment in Government Special Projects):
- The appropriation in the amount of P27,950,532.00 for Special Achievement Bonus shall be subject to existing budgeting, accounting and auditing rules and regulations.

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

Compliance with all existing laws, rules and regulations shall be the responsibility of the implementing local government unit concerned.
