

I am respectfully forwarding to your good office the following city ordinances which were approved by the Sangguniang Panlungsod for appropriate action, to wit:

1. **City Ordinance No. 440-2025 Series of 2025** – AN ORDINANCE DECLARING (1) THE "BACOR HEROES TOWER" AS THE OFFICIAL NAME OF THE SOON TO RISE STRUCTURE AT THE MABOLO FREEDOM PARK AND (2) DECLARING "MABOLO FREEDOM PARK" AS THE OFFICIAL NAME OF THE PLAZA SITUATED AT BARANGAY MABOLO, CITY OF BACOR, CAVITE.
2. **City Ordinance No. 441-2025 Series of 2025** – AN ORDINANCE REGULATING PARKING ON ALL ROADS AND SIDEWALKS SITUATED WITHIN RESIDENTIAL SUBDIVISIONS IN THE CITY OF BACOR, CAVITE, DEPUTIZING DULY ELECTED OFFICERS OF DULY-ACCREDITED HOMEOWNERS ASSOCIATIONS IN THE IMPLEMENTATION HEREOF, GIVING THE SAID ASSOCIATIONS A SHARE IN THE FINES TO BE COLLECTED IN THE PROCESS OF IMPLEMENTING THE SAME, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.
3. **City Ordinance No. 442-2025 Series of 2025** – AN ORDINANCE PRESCRIBING REGULATORY MEASURES TO IMPLEMENT THE POWERS AND FUNCTIONS OF THE CITY GOVERNMENT OF BACOR UNDER REPUBLIC ACT NO. 11592, OTHERWISE KNOWN AS THE "LPG INDUSTRY REGULATION ACT," TO ENSURE THE SAFETY, COMPLIANCE, AND REGULATION OF THE LIQUEFIED PETROLEUM GAS INDUSTRY, REGULATING THE SALE, TRANSPORT, DISTRIBUTION, AND STORAGE OF LPG WITHIN THE CITY OF BACOR, CAVITE, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.
4. **City Ordinance No. 443-2025 Series of 2025** – AN ORDINANCE AUTHORIZING THE CITY MAYOR TO DEPUTIZE BARANGAY TANODS AND OTHER BARANGAY PERSONNEL AS LAW ENFORCERS IN THE INSPECTION OF BUSINESS ESTABLISHMENTS RELATED TO THE IMPLEMENTATION OF VARIOUS CITY ORDINANCES AND PROVIDING INCENTIVES THEREFOR
