




CITY ORDINANCE NO. 450-2025 Series of 2025

AN ORDINANCE CREATING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) FOR DISTRICT EAST AND DISTRICT WEST OF THE CITY OF BACOOR, CAVITE, AUTHORIZING THE CITY MAYOR TO APPOINT ITS MEMBERS, AND FORMULATING POLICIES DESIGNED TO ENHANCE THE QUALITY OF SERVICE OF PHILIPPINE NATIONAL POLICE PERSONNEL ASSIGNED AT THE CITY OF BACOOR, CAVITE.

WHEREAS, Section 43 (a) of Republic Act No. 6975 (also known) as the "Department of the Interior and Local Government Act of 1990") as amended by Republic Act No. 8551 (the "Philippine National Police Reform and Reorganization Act of 1998") provides that "the sangguniang panlungsod/bayan in every city and municipality shall create such number of People's Law Enforcement Boards (PLEBs) as may be necessary: Provided, That there shall be at least one (1) PLEB for every five hundred (500) city or municipal police personnel and for each of the legislative districts in a city.

WHEREAS, Section 43 (b) of RA 6975 as amended provides that the PLE8 shall have "three (3) other members who are removable only for cause to be chosen by the local peace and order council from among the respected members of the community known for their probily and integrity, one (1) of whom must be a woman and another a member of the Bar, or, in the absence thereof, a college graduate. or the principal of the central elementary school in the locality."

WHEREAS, based on the 2020 census, the City of Baccor has a population of 664, 625 spread more or less equally in its 47 barangays.

WHEREAS, Section 10 of Republic Act No. 10160 (the "Charter of the City of Bacoor") created two districts referred to as Bacoor West and Bacoor East for purposes of representation in the Sangguniang. Panlungsod.


WHEREAS, the resolution of complaints filed by Bacobretios against police personnel assigned in the City of Baccor is hindered by the fact that only one People's Law Enforcement Board (PLEB) of Bacaar presently exists in the city.

WHEREAS, there is a need to create two PLEB's for the City of Baccor in order to speed up the process of exacting accountability. from police personnel accused of violating their oaths of duty.

WHEREAS, it is imperative that measures be formulated by the Sangguniang Panlungsod that will ensure that the PLEB performs its functions properly and promptly to enhance the quality of service. being rendered by police authorities and prevent abuses.

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Baccor, Cavite that:

Section 1. Creation of two PLEBs. There shall be two People's Law Enforcement Boards (PLEBs) in the City of Baccor, Cavite. One PLES shall handle all complaints against police personnel that were filed by residents of barangays located within Bacoor West and another PLEB shall handle all complaints against police personnel that were filed by residents of borangays located within Bacoor East.

Composition of PLEBs. The composition of the Section 2. PLEBs created under this Ordinance shall mirror the provisions of Republic Act No. 8975 as amended as well as perlinent government. regulations. Each PLES under this Ordinance shall be comprised of:



Section 3. PLEB Secretoriat. The PLEBs created under this Ordinance shall be assisted by a Secretariat to be headed preferably by a retired police officer residing in the City of Baccar who is wellregarded in the community for his/her integrity, competence, hardwork, and intelligence. The head of the secretariat shall be appointed by the City Mayor and shall serve in a co-terminus capacity. He/she shall receive salaries and emoluments allowed under pertinent civil service regulations. The PLEB Secretarial shall: (a) provide technical. administrative and clerical support to the PLEBs before, during, and affer its hearings, (b) take custody of all the official records of the PLEB, (c) furnish the Sangguniang Panlungsod and the City Mayor with copies of all of its Resolutions and Decisions not later than ten [10]. working days from the date of issuance of the said documents, (d) submit a summary of all cases it resolved or are still pending not later. than the 15th day of December each year following the date of effectivity of this Ordinance, and (e) perform such other fasks and functions as maybe mandated by the Peace and Order and Public Safety Council of the City of Baccor.

Removal from PLES. The members of the PLEB Section 4. appointed by the City Mayor may be removed for cause by the City. Mayor in accordance with law.

Section 5. Allowances. Members of the PLEB shall be given. monthly allowances as may be allowed by law subject to availability. of funds.

Awards and Recognition. Police personnel who Section & exhibited exemplary service over and above the call of duty, as recommended by the PLEB, shall be given cash rewards not less than Php 5,000,00 but not more than Php 20,000,00 as well as a Certificate. of Recognition. The awarding of the said rewards shall be done together with the schedule handing of the Gen. Edilberto Evangelista. Award and the Father Mariano Gomez Award.

Section 7. Live-streaming and Recording of Hearings. promote transparency and ensure the regular performance of their official duties, members of the PLEBs are hereby required to record all hearings of the PLEBs. The said hearings shall, whenever the exigency of public service requires, also be five-streamed subject to the provisions of the implementing rules and regulations of this Ordinance.

Implementing Rules and Regulations. The Office of S<del>ecflon</del> 8. the City Legal Service of the City of Baccoor snall submit the implementing rules and regulations of this Ordinance for the review and approval of the City Mayor not later than thirty (30) days from the date of effectivity hereof.

**Section 9. Repeal.** All ordinances, resolutions, executive orders and other local issuances inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 10. Separability. In case a provision hereof is declared void by a court of law of competent jurisdiction, the remaining provisions of this Ordinance not affected thereby shall remain valid and enforceable.

**Section 11. Effectivity.** This Ordinance shall take effect immediately after it has been posted in at least three (3) inconspicuous public places within the City of Baccor, Cavite.
