

City Ordinance No. 455-2025, Series of 2025 entitled: "AN ORDINANCE CREATING AND/OR ABOLISHING VARIOUS POSITIONS IN THE PLANTILLA OF THE OFFICE OF THE CITY SOCIAL WELFARE AND DEVELOPMENT, THE OFFICE OF THE CITY HEALTH SERVICES, THE BACOOR CITY CULTURE, HISTORY, ARTS, AND TOURISM OFFICE, THE CITY PLANNING AND DEVELOPMENT COORDINATING OFFICE, OFFICE OF THE CITY ENGINEER AND THE CITY ASSESSOR'S DEPARTMENT TO TAKE EFFECT ON FISCAL YEAR 2025 PURSUANT TO RELEVANT CIVIL SERVICE REGULATIONS".
