After a careful review of the instant ordinance, it was found that the same is in accordance with Section 458 of Republic Act No. 7160, also known as the "Local Government Code of 1991", which provides that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, to wit:

"(ii) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances;

(iii) Approve ordinances imposing a fine not exceeding Five Thousand Pesos (P5,000.00) or an imprisonment for a period not exceeding one (1) year, or both in the discretion of the court, for the violation of a municipal ordinance;"

Moreover, the said ordinance is consistent with Republic No. 10591, also known as "An Act Providing For A Comprehensive Law on Firearms and Ammunition and Providing Penalties For Violations Thereof".

It should be emphasized that the posting and publication of ordinances with penal sanctions should be compliant with the Local Government Code to be effective, as such:

"Section 511. Posting and Publication of Ordinances with Penal Sanctions. – (a) ordinances with penal sanctions shall be posted at prominent places in the provincial capitol, city, municipal or barangay hall, as the case may be, for a minimum period of three (3) consecutive weeks. Such ordinances shall also be published in a newspaper of general circulation, where available, within the territorial jurisdiction of the local government unit concerned, except in the case of barangay ordinances. Unless otherwise provided therein, said ordinances shall take effect on the day following its publication, or at the end of the period of posting, whichever occurs later."

WHEREAS, after having been reviewed by the said Committees and the Office of the Provincial Legal Officer, it was recommended for approval;

Pursuant to Section 16 in relation to Section 458(a)(1)(viii) of Republic Act no. 7160 (R.A. no. 7160) otherwise known as the "Local Government Code of 1991(LGC)," the Sangguniang Panlungsod shall enact ordinances necessary for an efficient and effective city government. These ordinances include determining the benefits of employees paid wholly or primarily from city funds and providing for expenditures essential for the proper implementation of the programs, projects, services, and activities of the city government.

Likewise, the proposed ordinance is also in accordance with the following:

1. *Civil Service Commission (CSC) Memorandum Circular (MC) No. 40, s. 1998, otherwise known as the "Revised Omnibus Rules on Appointments and other Personnel Actions," which address the changing needs of personnel administration.*
2. *Commission on Audit Circular No. 92-382, with the subject and purpose stated as: "This Circular on Accounting and Auditing Rules and Regulations is designed to implement the provisions of Republic Act No. 7160, the Local Government Code of 1991, and is issued pursuant to Section 2(2), Articles IX-D of the Constitution." The mission of the Commission on Audit (COA) is to promote transparency, ensure accountability for public resources, and improve government operation.*
