The said ordinance is in accordance with Republic Act No. 9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006" which mandates Local Government Units (LGUs) to Establish and support Local Councils for the Protection of Children (LCPCs) at the provincial, city, municipal and barangay levels, which are responsible for planning and implementing programs for children's welfare.

Moreover, the said Ordinance is in accordance with the DILG Memorandum Circular No. 021-039 dated April 7, 2021 which provides a Comprehensive Guidelines for the Establishment, Strengthening, and Monitoring of the Local Council for the Protection of Children at All Levels and for Other Purposes. And, it also complies with the publication requirement under the Local Government Code of 1991, Section 511(a).

NOW, THEREFORE, on motion of Hon. Enriquez, duly seconded by Hon. Anacan, Hon. Bautista, Hon. del Rosario, Hon. Gandia, Hon. Sarno, Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that City Ordinance No. 426-2025 from the City of Bacoor, be approved.
