- The savings certified available by the City Treasurer and City Accountant for supplemental appropriation are free of any obligations or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
- The appropriation in the amount of ₱16,870,000.00 for Performance-based Bonus shall be subject to the guidelines on the grant of PBB for officials and employees of LGUs jointly issued by the DILG and DBM.
- The total appropriation of P16,700,000.00 for Other Maintenance and Operating Expenses shall include only cost of services, which cannot be classified under any other account name and shall in no case be utilized or used for payment of salaries and/or other remunerations of personnel;
- 4. The appropriation for the following shall be subject to Sec. 335 of the Local Government Code, which provides that "No public money or property shall be appropriated or applied for religious or private purposes":
