WHEREAS, after having been reviewed by the said Committees and the Office of the Sangguniang Panlalawigan – Legislative Operations Division (OSP-LOD) and the Office of the Provincial Legal Officer (OPLO), it was recommended for approval:

After a careful and judicious review of the subject Ordinance, this Office finds no substantial legal infirmity that would prevent its enactment and passage. Section 186 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, expressly empowers local government units to levy taxes, fees, or charges on bases or subjects not otherwise specifically enumerated in the Code or in the National Internal Revenue Code, as amended, or other applicable laws. This authority, however, is circumscribed by the limitation that such taxes, fees, or charges must not be unjust, excessive, oppressive, confiscatory, or contrary to declared national policy, and that no ordinance levying such exactions shall be enacted without the conduct of a prior public hearing for the purpose.

In further support of the foregoing, jurisprudence has recognized and affirmed the fiscal autonomy of local government units. In Mandanas v. Ochoa, Jr. (G.R. No. 199802, 03 July 2018), the Honorable Supreme Court emphasized that fiscal autonomy is an indispensable element of local governance, encompassing the authority of local governments to create their own sources of revenue in addition to their just share of national taxes, as well as to allocate resources according to their priorities. This doctrine is integral to the viability of decentralization as envisioned under the Constitution and the Local Government Code.

Notwithstanding the foregoing authority, it is imperative that any revision or imposition of fees and charges be undertaken with due regard to stakeholder consultation. Such consultation ensures that the prescribed rates are equitable, just, and reasonable, and that unintended adverse consequences to the public and established priorities are avoided.

NOW, THEREFORE, on motion of Hon. Cantimbuhan, duly seconded by Hon. Anacan, Hon. Bautista, Hon. Enriquez, Hon. Gandia, Hon. Jaro, Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Joint Committee Report No. 134-12SP-2025 of the Committee on Ways and Means and the Committee on Land Use, Zoning, Urban Development and Housing be adopted, and that City Ordinance No. 449-2025 from the City of Bacoor be approved.
