

WHEREAS, after having been reviewed by the said Committee and the Office of the Provincial Human Resource Management Officer, it was recommended for approval:

This Committee finds City Ordinance No. 455-2025 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (RA 7160). We also find no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 20 October 2025, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed pursuant to Republic Act No. 7160, Section 76, which states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to minimum standards and guidelines prescribed by the Civil Service Commission" and subject to availability of funds and PS limitations. However, the following observations may take into considerations:

- For Section 3 "Abolition and Creation of Various Positions at the Plantilla of the Office of the City Social Welfare and Development" and Section 7 "Abolition and Creation of Various Positions at the Plantilla of the Bacoor City Culture, History, Arts and Tourism Office", it is suggested to indicate in the ordinance the item number of the position to be abolished for the comprehensibility of the request;
- For Section 6. "Creation of Various Positions at the City Assessor's Department", kindly check the following positions which seems to be not aligned with the DBM Local Budget Circular No. 137 "Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition" issued last July 13, 2021:
 - Instead of Driver I, it should be Administrative Aide III (Driver I);
 - Instead of Records Officer I, it should be Administrative Officer I (Records Officer I);
- For Section 8 "Creation of Various Positions in the Plantilla of the Office of the City Engineer", kindly check the following positions to be created:

- a. The position of Laborer II is not aligned with the DBM Local Budget Circular No. 137 "Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), Cy 2021 Edition" issued last July 13, 2021, it should be Administrative Aide III (Laborer II);
- b. For the Casual Employees to be created, it is suggested to specify the position title of the ten (10) casual positions to be created, for clarity of the positions, to identify their specific functions and to determine the qualification standards that should be used on the said positions.
