WHEREAS, after having been reviewed by the said Committees and the Office of the Provincial Human Resource Management Officer, it was recommended for approval:

These Committees find City Ordinance No. 452-2025 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (RA 7160). We also find no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 06 October 2025, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed pursuant to Republic Act No. 7160, Section 76, which states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to minimum standards and guidelines prescribed by the Civil Service Commission" and subject to availability of funds and PS limitations. However, the following observations may take in consideration:

- 1. For the position of Band Master (SG 9), it should be Bandmaster pursuant to DBM Local Budget Circular No. 137 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU) Revised 2021) issued last July 13, 2021. The required qualifications must be ensured that have been approved by the CSC as they must comply with the CSC Qualifications Standards (Revised 1997). and CSC Memorandum Circular No. 10 series of 2013 (Revised Policies on the Grant of Eligibility under CSC MC No. 11, series of 1996 as amended). It should be noted that the upgraded qualification standard of position must be approved first by the CSC prior to its publication.
- 2. For the position of Youth Development Officer I (SG 10) and Youth Development Assistant I (SG 5), the required qualifications must be ensured that have been approved by the CSC since, it does not conform to the CSC Qualifications Standards (Revised 1997). It should be noted that the upgraded qualification standard of position must be approved first by the CSC prior to its publication.
- For the position of Youth Development Assistant I (SG 5), it should be referred to the CSC Resolution No. 2500229 dated March 06, 2025 (Amendment to the Education Requirement for the First Level Position in the Government), for the education requirement.

WHEREAS, after having been reviewed by the said Committee, the Office of the Sangguniang Panlalawigan – Legislative Operations Division and the Office of the Provincial Legal Officer, it was recommended for approval:

Pursuant to Section 458 in relation to Section 17 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the Sangguniang Panlungsod as the legislative body of the city, has the power to enact and approve ordinances which shall ensure efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall:

"(xiv)Provide for the care of disabled persons, paupers, the aged, the sick, persons of unsound mind, abandoned minors, juvenile delinquent, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age; and subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons."

Moreover, in accordance with Section 458 in relation to Section 16 of the same Code, the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

"(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government."
