These Committees find City Ordinance No. 466A-2025 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (RA 7160). These Committees also find no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 02 December 2025, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed pursuant to Republic Act No. 7160, Section 76, which states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to minimum standards and guidelines prescribed by the Civil Service Commission" and subject to availability of funds and PS limitations. However, it was observed that there were no positions to be created nor position to be transferred to the aforementioned unit indicated on the said ordinance. As such, there should be a manpower indicated in the ordinance, for the created unit to function.

WHEREAS, after having been reviewed by the said Committee, the Office of the Sangguniang Panlalawigan – Legislative Operations Division and the Office of the Provincial Planning and Development Coordinator, it was recommended for approval:

The Office of the Sangguniang Panlalawigan, in its review letter dated November 11, discussed that:

Under Section 19 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," it states:

Section 19. Eminent Domain. - A local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the poor and the landless, upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws: Provided, however, That the power of eminent domain may not be exercised unless a valid and definite offer has been previously made to the owner, and such offer was not accepted: Provided, further, That the local government unit may immediately take possession of the property upon the filing of the expropriation proceedings and upon making a deposit with the proper court of at least fifteen percent (15%) of the fair market value of the property based on the current tax declaration of the property to be expropriated: Provided, finally, That, the amount to be paid for the expropriated property shall be determined by the proper court, based on the fair market value at the time of the taking of the property.

Section 458 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" provides:

(a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code

1. The ordinance correctly invokes Section 19 of the Local Government Code of 1991 (RA 7160), authorizing local government units to exercise the power of eminent domain through an ordinance and upon payment of just compensation. Legislative records indicate that City Ordinance No. 464-2025 was duly passed on Second and Final Reading, certified by the Sangguniang Panlungsod Secretariat, attested by the Presiding Officer, and approved by the City Mayor on 28 October 2025, consistent with the procedural requirements of the Local Government Code.
2. The Ordinance states that, despite the City Government's offer to purchase the property, the registered owner failed to respond. This satisfies the requirement of undertaking prior good-faith negotiation before the filing of an expropriation case. However, for future expropriation measures, it is advisable that supporting documents, such as the written offer to purchase, proof of service, and corresponding dates of transmittal, be attached to more clearly demonstrate compliance with the rule on prior negotiation.
3. The property is sufficiently described through details of the Transfer Certificate of Title (TCT No. T-79371), lot area (71,036 sqm), location in Barangay Molino II, and corresponding tax declaration number. The ordinance states that the City Government evaluated several potential sites and determined that the subject property is the most suitable location for the establishment of an in-city resettlement and township development project for informal settler families and economically challenged households living in danger zones and areas affected by government projects.
4. While the ordinance clearly identifies a valid public purpose, there is no express statement confirming that the proposed resettlement and township development project is consistent with the City's Comprehensive Land Use Plan (CLUP) and Zoning Ordinance. For land acquisition and expropriation cases, it is recommended that future ordinances explicitly cite the zoning classification and confirm that the intended use is allowable or compatible with the applicable zoning regulations.
5. Section 3 of the ordinance authorizes the City Mayor or his duly authorized representatives, through counsel, to initiate expropriation proceedings on behalf of the city. This is consistent with the mandate of the Local Government Code and aligns with standard expropriation procedure.

6. The ordinance provides that the amount necessary to cover filing fees, deposits, cost of the property as determined by the Court, and other expenses shall be sourced from the General Fund or other lawful sources.
7. To enhance documentation, transparency, and compliance with planning and legal standards, the following are respectfully suggested for future measures involving eminent domain:
 - Explicitly state the zoning classification of the subject property and certify its compatibility with the intended public use.
 - Attach or reference the written offer to buy, proof of service, notices sent to the owner, and other negotiation documentation.
 - Annex the lot plan, vicinity map, and technical description for clarity and ease of verification.
 - Indicate the results of any site suitability assessments, community consultations, or technical evaluations undertaken by the Local Housing Board and the City Planning and Development Office.
