WHEREAS, after having been reviewed by the said Committee and the Office of the Provincial Human Resource Management Officer, it was recommended for approval:

This Committee finds City Ordinance No. 472-2025 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (RA 7160). This Committee also finds no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 10 December 2025, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed pursuant to Republic Act No. 7160, Section 76, which states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to minimum standards and guidelines prescribed by the Civil Service Commission". However, it was observed that there were no budget appropriations indicated on the said ordinance. As such, all positions to be created must have budget appropriations to be included on the Plantilla of Personnel.

NOW, THEREFORE, on motion of Hon. Sison, duly seconded by Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it
