- CITY ORDINANCE NO. 441-2025, series of 2025 entitled "AN ORDINANCE REGULATING PARKING ON ALL ROADS AND SIDEWALKS SITUATED WITHIN RESIDENTIAL SUBDIVISIONS IN THE CITY OF BACOOR, CAVITE, DEPUTIZING DULY ELECTED OFFICERS OF DULY-ACCREDITED HOMEOWNERS ASSOCIATIONS IN THE IMPLEMENTATION HEREOF, GIVING THE SAID ASSOCIATIONS A SHARE IN THE FINES TO BE COLLECTED IN THE PROCESS OF IMPLEMENTING THE SAME, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF";

CITY ORDINANCE NO. 442-2025, series of 2025 entitled "AN ORDINANCE PRESCRIBING REGULATORY MEASURES TO IMPLEMENT THE POWERS AND FUNCTIONS OF THE CITY GOVERNMENT OF BACOOR UNDER REPUBLIC ACT NO. 11592, OTHERWISE KNOWN AS THE "LPG INDUSTRY REGULATION ACT," TO ENSURE THE SAFETY, COMPLIANCE, AND REGULATION OF THE LIQUEFIED PETROLEUM GAS INDUSTRY, REGULATING THE SALE, TRANSPORT, DISTRIBUTION, AND STORAGE OF LPG WITHIN THE CITY OF BACOOR, CAVITE, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF"; and
- CITY ORDINANCE NO. 443-2025, series of 2025 entitled "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO DEPUTIZE BARANGAY TANODS AND OTHER BARANGAY PERSONNEL AS LAW ENFORCERS IN THE INSPECTION OF BUSINESS ESTABLISHMENTS RELATED TO THE IMPLEMENTATION OF VARIOUS CITY ORDINANCES AND PROVIDING INCENTIVES THEREOF".
