

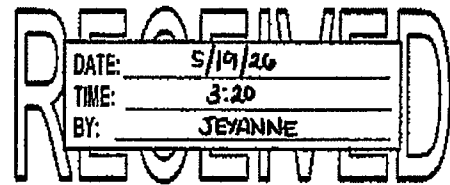

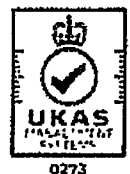
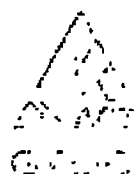

3. **City Resolution No. 2026-1004A, Series of 2026** – A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 FOR THE SUPPLEMENTAL BUDGET NO. 1 OF THE CITY OF BACOOR, PROVINCE OF CAVITE AMOUNTING TO FOUR HUNDRED FORTY-SEVEN MILLION FIVE HUNDRED SEVENTY-TWO THOUSAND EIGHT HUNDRED FOURTEEN PESOS (PHP447,572,814.00) FOR CALENDAR YEAR 2026.
