












*After a careful review of the ordinance submitted by City of Bacoor, this Joint Committee finds that the proposed measure is consistent with the Constitution, the Local Government Code of 1991 (R.A. 7160), the New Government Procurement Act of 2024 (R.A. 12009), and other applicable laws, this Joint Committee interposes no objection to its approval.*


*Under Section 468(a)(5) of the Local Government Code, the Sangguniang Panlalawigan has the authority to exercise powers and perform duties prescribed by law or ordinance, enabling the provincial government to implement national policies within its jurisdiction. Section 16 further empowers cities to enact ordinances promoting the general welfare of their constituents. In this regard, the ordinance aligns with the constitutional mandate under Article II, Section 16 of the 1987 Constitution to protect and advance the right of the people to a balanced and healthful ecology.*

*The ordinance is consistent with national environmental and procurement policies. Section 20 of R.A. 9003, the Ecological Solid Waste Management Act, mandates that local government units achieve a minimum 25% waste diversion quota. The ordinance's initiative to repurpose plastic wastes for furniture directly supports this objective. Executive Order No. 301, Series of 2004, requires government agencies to incorporate environmental criteria in procurement decisions, while R.A. 12009 mandates that all procuring entities establish sustainable public procurement programs to achieve value for money while minimizing environmental impacts. Through life-cycle costing, local government units may consider energy efficiency, durability, waste reduction, and long-term ecological effects in procurement decisions, ensuring that sustainability is integrated into both environmental and fiscal management.*

*Procedurally, Section 56 of the Local Government Code provides that the Sangguniang Panlalawigan has thirty days to examine ordinances submitted by component cities and municipalities. The ordinance was received on 03 December 2025, and since the thirty-day period lapsed on 02 January 2026 without any declaration of invalidity, it is presumed consistent with law and therefore valid.*

**WHEREAS**, after having been reviewed by the said Committees, the Office of the Provincial Vice Governor and the Office of the Provincial Legal Officer, it was recommended that the legal opinion and recommendations rendered be adopted by the Sangguniang Panlungsod of Bacoor;

*Pursuant to Section 56 of the Local Government Code, the Sangguniang Panlalawigan is granted a period of thirty (30) days from receipt of ordinances or resolutions of component cities and municipalities within which to examine the same and declare whether such enactments are invalid in whole or in part. Records show that City Ordinance No. 476-2025 was received on 03 December 2025. The thirty-day review period therefore lapsed on 02 January 2026 without any adverse action taken, rendering the ordinance presumed consistent with law and therefore valid.*

*After a careful review of City Ordinance No. 476-2025 of the City of Bacoor, this Committee finds the following observation and recommendations:*

*Section 458 of the Local Government Code expressly empowers the Sangguniang Panlungsod to enact ordinances necessary for an efficient and effective city government, including ordinances authorizing the issuance of permits and licenses and prescribing conditions intended to promote the general welfare of the city's inhabitants. The subject ordinance falls well within this legislative authority.*

*Nevertheless, while recognizing the autonomy of local government units in determining their policies and regulatory requirements, the Committee emphasizes the need for consistency with relevant national government issuances. In this regard, the Committee strongly recommends that due consideration be given to the following:*

- BLF Memorandum Circular No. 001-2020, on updated reminders in the assessment of local business taxes and the registration and renewal of business permits and licenses; and
- DILG-ARTA Joint Memorandum Circular No. 2021-01, on the guidelines for streamlining LGU systems and procedures for business- and non-business-related services.

*In addition, to further strengthen the ordinance and ensure its effective and constitutional implementation, this Committee respectfully recommends the following amendments and clarifications:*

1. Section 4(a) – Rephrase the provision for clarity and expressly include definitions of the terms “Fixer” and “Fixing” to avoid ambiguity and clearly identify prohibited conduct and responsible persons;
2. Sections 4(b) and 4(c) – Rephrase the provisions to provide a clear, specific, and definite enumeration of prohibited acts, particularly considering their relevance to enforcement and procedural due process;
3. Section 4(k) – Specify the particular acts, processes, or procedures contemplated under the phrase “any other act, process, or procedure that unduly burdens applicants,” and provide illustrative examples to guide interpretation and application;
4. Section 10.1(a) – Reconsider the use of the term “automatically approved” for Fire Safety, Sanitary, Building, and similar permits in cases where inspections are not conducted within the prescribed period, and instead adopt the term “provisionally approved,” in view of the public safety implications involved;
5. Sections 12 and 13 – Provide that the service of a Notice of Violation may be effected not only through electronic mail but also through personal service or registered mail, to ensure proper notice and due process.

*In view of the foregoing, the Committee reiterates that this Ordinance is presumed valid. However, this Committee puts emphasis on the foregoing recommendations, which are respectfully submitted to enhance its clarity, enforceability, and compliance with constitutional and statutory requirements.*

NOW, THEREFORE, on motion of Hon. Salazar, duly seconded by Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it **RESOLVED, AS IT IS HEREBY RESOLVED**, that Committee Report No. 347-12SP-2026 of the Committee on Ways and Means be adopted, and that City Ordinance No. 476-2025 from the City of Bacoor, with a recommendation that the legal opinion and recommendations rendered, be adopted by the Sangguniang Panlungsod of Bacoor;

**RESOLVED, FURTHER**, that the City of Bacoor takes note of the aforementioned recommendations.
