WHEREAS, after having been reviewed by the said Committee, the Office of the Provincial Vice Governor, Office of the Sangguniang Panlalawigan, and Office of the Provincial Legal Officer, it was recommended for approval:

The Office of the Provincial Legal Officer, in its letter dated 24 February 2026, to be APPROVED.

"After careful study of the above stated ordinance, this Office humbly states that the proposed ordinance is in consonance with the 1987 Constitution, the Local Government Code of 1991, and other statutes and enactments.

However, although the ordinance does not display the name, image, or logo of Hon. Strike Bautista Revilla, the incumbent Mayor of Bacoor City, on any current paraphernalia, it nevertheless constitutes a circumvention of the "Anti-Epal" Policy.

By designating the program as Malasakit Sa Bawat Residente or the MSBR Program, it effectively ties or implies the identity of Mayor Strike Revilla to a government-funded program, thereby treating it as a personal initiative. This form of indirect branding falls squarely within the prohibited act sought to be prevented by the Anti-Epal policy, whose core prohibition is the association of public infrastructure with the personal identity of a public official. To emphasize, the acronym of Mayor Revilla is Mayor Strike B. Revilla or MSBR, which is exactly the same as the program name.

Notably, based on recent government directives, particularly DILG Memorandum Circular No. 2026-006 issued on January 29, 2026, and the provisions of the 2026 General Appropriations Act, the State has reiterated and reinforced the so-called "Anti-Epal" policy, which prohibits public officials from using government-funded projects, programs, and activities for personal publicity or self-promotions.

The policy also covers acts of political credit-grabbing, including the use of government-funded aid or projects to advance political interest or portray personal generosity. Its coverage applies generally to all elective and appointive local government officials at all levels. DILG-attached agencies such as the Philippine National Police, and even national officials.

Lastly, under Section 9. Funding, it is recommended that the PNP-Bacoor be removed as one of the offices as to whom the present ordinance will obtain their funding. The charges or expenses its connection to the present ordinance must only come from the local government and they cannot compel another institution to share in the ordinance's operational expenses or budget. This is primarily because of the principles of fiscal autonomy, the limitation of territorial jurisdiction, and the subordination of local laws to national law. Local Government Units cannot legislate binding financial obligations upon national agencies that are funded through separate, specific, appropriations by the State."

The Office of the Provincial Vice Governor, through Atty. Nathaniel C. De Leon, in its letter dated 10 February 2026, expressed no objection to the approval of the said ordinance.

The Sangguniang Panlungsod of the City of Bacoor is empowered by Section 458 of the Local Government Code and Section 11 of R.A. No. 10160 or Charter of the City of Bacoor to approve ordinances to maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition, and enact ordinances intended to prevent, suppress and impose appropriate penalties for habitual drunkenness in public places, vagrancy, mendicancy, prostitution to promote the general welfare of the people."

RECOMMENDATIONS

While the measure is consistent with constitutional and statutory authority, it must be revised to avoid indirect branding that circumvents the Anti-Epal policy. Specifically, the committee recommends that:

- The program name *Malasakit Sa Bawat Residente (MSBR)* should be changed to a neutral title that does not tie the initiative to Mayor Strike Revilla's identity;
- The ordinance must ensure with national directives such as DILG Memorandum Circular No. 2026-006 and the 2026 General Appropriations Act, which prohibit the use of government funded projects for personal publicity or political credit-grabbing;

- b. The creation of seven (7) permanent and thirty-seven (37) casual positions shall be subject to the Personal Services (PS) limitation prescribed under Section 325(a) of R.A. No. 7160 and the minimum standards and guidelines prescribed by the Civil Service Commission (CSC) pursuant to Section 76 of the Code. Likewise, the authorized salary rate for each position shall be equivalent to the 1st step of the salary grade allocation based on the salary schedule being implemented by the City Government;
- c. The casual positions shall be subject to Section 9(g), Rule IV of the Omnibus Rules on Appointments and Other Human Resource Actions. 
