Meanwhile, R.A. No. 12314 or the General Appropriations Act particularly provides:

"Sec. 20 prohibits the display and/or affixture of the name, image and likeness of public officials on government projects and the display and/or affixture of the name, picture, image, motto, logo, color motif, initials, or other symbol or graphic representation associated with any public official, whether elected or appointed, on signboards for all programs, activities, and projects funded under said Act."

More recently, the Department of the Interior and Local Government issued DILG Memorandum Circular No. 2026-0062 on the Prohibition on the Display and/or Affixture of the Name, Image, and Likeness of Public Officials on Government Projects.

The DILG reiterated and institutionalized the policy of prohibiting the display and/or fixture of the name, image, or likeness of public officials on government-funded projects, programs, activities, and properties in order to promote professionalism in public service, and uphold the principle that government undertakings are funded by public resources and not by individual officials.

The obligation of the Philippine government to provide safe, durable, and functional buildings as evacuation centers is anchored in the 1987 Constitution, national legislation-particularly Republic Act No. 12076-and the statutory mandates of local government units. The Constitution underscores the State's duty to promote the general welfare, protect life and property during emergencies, and uphold human dignity and rights. This policy is operationalized through the Ligas Pinoy Centers Act (RA 12076), which expressly requires every city and municipality to establish permanent and disaster-resilient evacuation centers designed to withstand strong typhoons and earthquakes and equipped with essential facilities such as sanitation areas, health rooms, kitchens, and child-and women-friendly spaces, thereby avoiding the use of schools as shelters. Supplementing this are the Local Government Code, the Disaster Risk Reduction and Management Act (RA 10121), and the Children's Emergency Relief and Protection Act (RA 10821), which jointly mandate LGUs to undertake emergency measures, strengthen disaster response capacity, and ensure the availability of safe and complete evacuation facilities. These duties are further strengthened by the National Building Code and DILG issuances requiring structurally sound, properly located, and adequately equipped evacuation centers.
